## 2. Please provide a brief description of what you are screening

This EDCI screening is being completed in relation to a recommendation to approve receipt (into LCC and the project's cost centre 50537) and authority to spend 4 elements of funding already secured to develop, in collaboration with health & care partners, an outline business case to take forward the proposed development of Burmantofts Community Wellbeing Centre on the LCH-owned Burmantofts Health Centre site, and to continue the commission Community Ventures Leeds. The 4 funding elements are: £242k One Public Estate Programme Phase 9 funding, £150k combined health system funding, £50k Local Centres Programme funding and £45k iBCF funding.

For the purpose of this screening only the processes relating to receiving and spending the funding for the outline business case (OBC) stage is considered. If the project progresses beyond the OBC stage, further funding will need to be secured to complete

a Full Business Case, which will be subject to a further EDCI screening. It is anticipated that a full equality impact assessment will be required at that stage as the project will have far more certainty of delivery by that time.

In 2019 £120k was secured through iBCF to cover the cost of development of an outline business case. Initial stakeholder engagement, intelligence gathering and analysis have been undertaken, potential solutions identified and a strategic outline case approved by senior decision-makers. In order to progress further and complete an outline business case additional funding is now required.

During the outline business case development process options will be examined in detail, stakeholders engaged, design concepts produced and possible funding routes identified.
