2. Please provide a brief description of what you are screening

- The DfE has made available grant funding to improve the adoption system for vulnerable children and young people since 2019. The grant for 2022/23 2024/25 is intended for activity on a national and regional scale in support of the National Adoption Strategy.
- A decision was taken on 13/05/2022 to enter into an agreement and accept grant funding from the DfE. Grant funding would be managed by the National Strategic Lead and OAWY on behalf of all Regional Adoption Agencies (RAAs) to undertake activity on a national and regional scale in support of the National Adoption Strategy, with Leeds City Council acting as the lead local authority.

- Successful bidders will be awarded with cooperation agreements/contracts for up to three years working on early permanence and matching, improving outcomes for cyp nationally.
- The aim is for all adoptive children to be found permanent loving families as quickly as possible where they will be safe and secure; adopters are recruited from all communities so that we have a range of approved parents able and well prepared to meet the needs of children waiting to be adopted and that children and families get the support they need when they need it.
