2. Please provide a brief description of what you are screening

The council Housing Growth Programme is currently working towards a challenging delivery target of 1,500 new Council homes across the City by March 2025. This is a 5-year programme which targets a linear average of 300 homes p.a.

This is being achieved predominantly via a substantial new build programme but is also complemented by a property acquisitions programme – with a focus on repurchasing former council properties bought under the right to buy regime, including those to which the statutory right of first refusal regime applies.

The council commenced work on this new 'buyback' project in late 2018 and is now ready to progress further re-purchases. These properties will be reintroduced to council housing stock to be let to council tenants.

Acquisition of these new council homes directly contributes to delivering the Leeds Best City Ambition pillars of Health & Wellbeing and Zero Carbon by:

- Providing housing of the right quality, type, tenure and affordability in the right places.
- Minimising homelessness through a greater focus on prevention.
- Addressing the challenges of housing quality and affordability, tackling fuel poverty and creating vibrant places where residents have close access to services and amenities.
