<p>A Service Level Agreement (SLA) is required between Leeds City Council and Groundwork Yorkshire Limited to set out how the partnership between the two organisations will operate, to provide maximum benefit for the people of Leeds.</p> <p>The SLA provides a baseline of responsibilities and relationships between the Council and Groundwork Yorkshire Limited. It provides a clear definition and understanding of how they will support and work together in relation to the resources provided by or through the Council to the Trust with the purpose of achieving the Council’s priorities, aims and objectives.</p>

Groundwork Yorkshire Limited will prepare an annual Delivery Plan outlining all projects they intend to implement in that financial year and demonstrate how they contribute to Team Leeds and the Best City Ambition.

All the projects will provide enhanced greenspace and/or improved facilities for the public and will be developed following consultation with existing and potential users. Equality, diversity, cohesion and integration is included in this process to ensure that the amenities are open and accessible to all. Each project has its own separate governance arrangements including individual EDCI screens where required.
