I wish to object to the above variation, increase to the current premises licence for the following reasons:-

The increase to the licencing hours of the club house will lead to more traffic using Casson Avenue in the evening and at the weekends to the detriment of local residents. This means that local children will not be safe when using Casson Avenue for outside play or when riding their bikes. We already suffer from excess traffic and parking issues when certain matches or tournaments are played.

Noise disruption for local residents as sound travels and the increase in noise from the club house as people leave (either in cars or walking) will encroach on people's enjoyment of using their gardens or wake up children if later in the evening. This is not good when they will be attending school the next day.

The sale of alcohol for drinking off the premises will lead to an increase in litter as bottles and cans will be discarded in the local vicinity, to the detriment of the environment.

It could also lead to a increase in underage drinking as who is going to monitor the sales for off premises consumption.

The Crescent field is not the sole preserve of Tingley Athletic Football club, it is also used by local residents as a green space and if people are drinking alcohol outside or leaving the premises after a drink, people particularly women or children could feel or be intimidated. This would mean that they would be less likely to use the field for exercise or playing which is in effect taking away a much needed green space from local residents that we are paying for from our council tax.

The requested increase in licencing hours means that the club house is going to be used as more of a public house than a sports club. This is not appropriate for its location in a quite residential area. When Tingley Athletic were given planning permission for the club house they said it was to provide storage and changing facilities for the children and young people playing football there.

Selling alcohol every night and nearly all day at weekends does not seem to fit with the ethos of encouraging people to get or stay fit through sport.

I sincerely hope that this application is denied by Leeds City Council.

I am writing with regards the above license application and letter received on 31st October 2022.

I object to this.

Over the years since the premises have been opened, I have experienced continuous parking problems. Sometimes being unable to get in/out of my own drive way.

As residents, we cannot understand why the entrance does not come off The Crescent as the entrance and exit hold up traffic on Common Lane with the traffic coming from Casson Avenue. This is increasing and getting worse. It will be affected even more if the opening times are extended for Tingley Athletic FC.

I object to the premises having a licence. Public safety is a large issue. There are already safety issues with how all the cars are parked on the grass verges and roads on Common Lane. There is no other parking for the club house and people use Casson Avenue to park. It will only get worse if the times of opening are increased.

Children are at greater risk with families visiting to play sports, coming in their cars, and then run the risk of leaving the cars until the following day, not being able to drive home because of their alcohol intake. It also opens up to families actually using the cars being intoxicated because of the alcohol being sold.

Public nuisance could increase as it will be late on an evening when persons will be leaving. Possibly drunk and disorderly. Then cars late at night driving up/down Casson Avenue. (It is an Avenue as stated. Not suitable for parking on with all these cars).
