Dear Entertainment licensing – please see below comments from Alex Sobel MP.

‘Dear Ms Archibold

I am writing to make comments in relation licence application PREM/05009/001.

I am led to understand that the application is for a bar/cafe/restaurant rather than a bar/public house. Although not stated on application (which would have alleviated some concerns for residents) we have been advised alcohol will be ancillary to food provision.

The applicant owns Residence 74 a cafe on Otley Old Road, which I understand is a seated, family friendly cafe/restaurant in which alcohol can also be purchased. Similar in nature to Heaney and Mill, The Vinyl Whistle and Growlers in Headingley.

I am aware of the significant issues arising from licenced properties in Headingley, Hyde Park and Weetwood, therefore I know this will cause some concern to residents, and as such I would ask that if this licence is granted the following conditions are included:

- Alcohol can only be purchased with food
- Alcohol must be consumed seated
- No admittance to groups in fancy dress/or engaging in the Otley run’
