Brief summary

On 21st October, the Mayor's Cost of Living Emergency Fund was announced to support the key regional ambition of delivering an inclusive economy.

The Fund is part of a regional package of targeted measures agreed by West Yorkshire Mayoral Combined Authority in response to the cost of living crisis.

This report is to accept tranche 1 (and any future tranches) of the funding, and to use £248k of this to fund the costs of running a 'warm spaces' network in Leeds. In addition, a further amount of £75k will be used to provide additional support to organisations currently delivering the Leeds Advice Contract.

Recommendations

a) For the Chief Officer for Community Hubs, Welfare and Benefits approves the Significant Operational Decision to accept the funding, and to use this as set out in the report.

What is this report about?

1 This report is in reference to the West Yorkshire Mayoral Funds, the accepting of these funds and their proposed use with regard to funding the cost of a 'warm spaces' network, and to provide additional support to Leeds Advice Contract providers

What impact will this proposal have?

- 2 This proposal will ensure the delivery of a Leeds 'warm spaces' network over the colder winter months providing essential heated spaces to those who may struggle to afford to heat their own homes during the current Cost of Living crisis. The funds will also ensure that advice provision can continue to meet the current extreme high demand (due to cost of living issues).
- 3 Consideration has been made regarding the requirement for an ECDI associated to this work, however both the Warm Space provision and the Leeds Advice Contract are accessible to all customers who may need the support, and are both city wide provisions. Therefor there is no requirement for an ECDI at this stage.
