I live in and our flat faces the royal armouries and newdock hall, I dont think they should be applying for alcohol until 2am and entertainment until 3am. people leaving the venue directly below me scream, shout and are noisy until the early hours with no control. I have been down or shouted off my balcony for years now infrquently. I even tried to speak with a manager but the security wouldnt call for her when I asked

you dont need alcohol to have a good time this can be seen at pizza express, mumtaz restaurant and the recent canary bar that clsoe at 11pm.

we have multiple venues that sell alcohol including the cafe in the royal armoures during the day and the canary, tesco and an up coiming event space being built where the casino is.

a lot of people live here and I can garentee the noise from finishing at newdock hall is repetative, nuisance and noisy especually this time of year. I think like other venues the alcohol and entertainment times should be capped at 11pm and no later. people dont need to eat or drink at midnight and if they do they can walk into the city centre that is only 5 minutes away.

people having parties go outside to smoke and they stand on the side of the 2ndfloor suite function room and see who can throw the cigarette buts in the water the furthest. I often have to pick my dog up walking past the armouries due to the broken wine and tumbler glasses that are all over the floor. I can only assume being thrown off the side of the armouries at night just above where the big red shop sign is.

2 the times applied for until 3am!! is ridiculous and online it says their opening hours are until 3:30am. I'm not sure why they would want these times, they seems to close about 1am with people hanging around outside until later they not be passing the time of midnight 12am.

if people are out this time i object to the later hours, they do day functions, exhibitions and events they should start earlier if they want customers to have a wild drunken time throwing glasses being loud throwing cig ends in the water

I object to the application for New Dock I tried to do it online but an error accered

Right now it's 1:50am and people are outside shouting, screaming and smoking. not sure how this is allowed if they have no licence. There is no and very little effort put in from the organisers to control the shouting. at 1:50 in a majority residential area it shows little respect

I object on the grounds of public nuisance. Noise from customers leaving have not been address and I presume won't be addressed if the licence is granted. a lot of residents in the area work night or even later and coming home, I have the right to not listen to hooligans due to over intoxication. Also staff empty bottles in big green wheely bins

The area in general is starting to bustle and become nice apart from the occasional parcel thief, drunken students and the customers of the royal armouries/new dock

Crime. its been sighted that both the new dock and the main royal armouries that carling glasses have been smashed outside and all along the outside customer accessible areas of the buildings, the unfortunate job of cleaning the broken glass is left to the poor maintenance guy the next time he's on shift.

Its often people in tuxedos walk down to Tesco buy alcohol and down the cans and bottles as fast as they can, I expect the prices inside the venue are extortionate. its also been spotted on several occasions and without jumping to conclusions. drug use. groups of lads again waiting around after taking out cash from the cash machine at Tesco and waiting for baggie drop offs. and sometimes its blatantly obvious. we've all been there. It just goes to show that the door searches are minimal

the site also have applied until 3am. this time should be brought back to 11pm to fall in line with the other amenities. Im not sure why they are asking for 3am as the never seem to meet that time. if that's the case they they won't miss the hours being reduced. I think it could be the organisers trying their luck.

Summery:

Taken in to account the noise and nuisance from leaving customers, the safety of the public from broken glass, irresponsible fast drinking and drug taking from customers and a business pushing their luck with extremely unreasonable times. could you consider my points and ask the organisers

- 1 why do they need a 3am licence?
- 2 what measures have they put in place throughout the years on customer dispersal?
- 3 why have the measures in question 2 never worked?
- 4 does profit override the respect for local residence?
- 5 does a business need 18 hours every day of solid alcohol sales over multiple buildings and floors?
- 6 do the organisers think 18 hours of alcohol and other activities each day are excessive and if not why?

I would urge the decision maker and licensing authority to ask the above questions and use their expertises to decide if the answers are reasonable and just for the local residents which live with 18 hours of nuisance daily. I would also ask the decision maker and licensing authority to ultimately respect my wishes and consider reducing the hours from 18 a day to 14 (reduce by only 4 hours until 11pm to fall in line with other sites around the area). I'm not asking for the business to close and I think this is extremely reasonable. 14 hours a day is more then enough time to have a great time. no one drinks or dances or boxes for more then 10 hours let alone 14 hours unless it was some major festival which its not.

- 3 I pride myself on living in a nice area. its a shame its spoiled on a regular occasion
- 4 me, residents and pets shouldn't have to dodge broke glass every morning 5 me, residents have respected the organisers loose management for years. they should now meet halfway and respect ours.
- 6 I wish I had time to drink 18 hours a day! I'm writing this objection now because I work 18 hour days (not literally) like a lot of other people in my personal opinion 14 hours is more than enough while keeping residents happy, party goers happy and a nice stream of money flowing for the business. win win situation.
