- 1.2 Members are required to consider this application due to the receipt of an objection notice from the Environmental Protection Team.
- 2 The temporary event notice
- 2.1 The proposed premises user is Merita Kasa.

Sale of Alcohol Provision of Late Night Refreshment Regulated Entertainment

From 20:00 hours on the Sunday 1st January 2023 to 01:00 on Monday 2nd January 2023

- 2.4 The location of the premises can be seen on the map at Appendix B.
- 2.5 There is no premises licence in force for these premises.

3 Representations

- 3.1 West Yorkshire Police and LCC Environmental Protection Team have received a copy of the notice.
- 3.2 Environmental Protection Team consider that allowing the premises to be used in the manner set out in the temporary event notice will undermine the prevention of public nuisance licensing objective and have issued an objection notice.
