Good Afternoon

I have been asked by [REDACTED] to provide feedback on the Mint Festival being held in the Selby District in both 2018 and 2019.

In both years, the Mint Festival was held at Church Fenton Airfield, which already had a premises licence in place for up to 20,000 people. As part of the licence conditions planned events had to be brought to the attention of the Safety Advisory Group (SAG) and only when the SAG members were satisfied with the event management plan would the Licensing Authority sign off the event in writing for the event to go ahead.

The Event organisers worked well with all of the SAG members, this involved a number of site visits and meetings over a number of months. Information was shared regularly and when information was requested a quick response was usually given and any issues found in the plan were rectified/implemented.

Officers from Licensing, Police Licensing and Environmental Health attended the events. From a Selby Council Licensing perspective we found that the event was well run and managed well. We were satisfied that the event organisers had done everything asked of them.
