2. Please provide a brief description of what you are screening

Decision to award 7 grant agreements to Regional Adoption Agencies in support of the development of Centres of Excellence for Adoption Support. This follows a decision taken in May 2022 for Leeds to accept grant funding from the Department for Education and act as a Lead Authority to commission services supporting the National Adoption Strategy.

The agreements will run for a period of up to two years from 01/04/2023 to 31/03/2025 and will be for values between £243,000 and £956,000 per year as detailed in appendix 1 of this report. The sum of all the agreements over the two-year period will be just under £4 million.

The activities and projects commissioned have been determined by the RAA Leaders' Group, with a focus on the exploration, creation, and development of a support system, which are delivered, and sustainably funded, in partnerships between the adoption agency, health and education sector and the local authorities.
