Clusters are a fundamental part of the Early Help strategy, Children & Young People's Plan and the Best Council Plan. Clusters support the best council plan outcomes of:

Clusters were founded in local school partnership arrangements around the Extended Services agenda and have evolved over the last ten+ years to become the infrastructure to deliver early help services.
