
1,230 consultation feedback surveys completed (1,203 online, 25 via events, 2 via post)













How do you normally travel?











Postcode mapping


- 937 respondents provided their postcode (first half of postcode)



Question One: How do you feel about our proposals for the Calverley Lane accessible bridge?'









Question Two: Section 9 - why do you feel like this?
















Age results cross referenced with sentiment for mixed use path














Age results cross referenced with sentiment for Rodley roundabout












Age results cross referenced with overall scheme sentiment












Gender results cross referenced with sentiment for mixed use path










Gender results cross referenced with sentiment for no right turns












Gender results cross referenced with sentiment for safety proposals








Gender results cross referenced with sentiment for overall scheme





Key successes

- 1230 respondents
- Overall sentiment of respondents 74.4% positive
- 1000 more Connecting Leeds subscribers
- 50/50 male & female responses
- 93.3% of respondents found the consultation materials very easy or easy to understand.







Considerations for future consultations

- Equality Diversity & Inclusion (EDI) group representation -Focus LIP engagement with 13-15/16-24 groups and faith groups
- Best practice Consultation closed update/report upload
- Reduce in-person events as they weren't all well attended.
- Liaise with local councilors earlier to agree locations of events.
- Consider webinars with Q& A sessions and/or narrated videos.
- Try and mitigate a delay from highways providing technical info. This had a knock on effect of delaying the start date by 5 weeks.
- Ensure the web link to the consultation page lands directly on the survey







Next steps

- Fink Hill start on site (main scheme)
- Detailed design completion
- Approvals for the Phase 2 works
- Site investigations and surveys
- Pre-App advise for accessible bridge and ramp
- Advance material procurement to mitigate cost inflation
- Delivery of average speed cameras (messaging via Press Release)
- Continued dialogue with the DfT
