

## SCHEDULE 1

### APPLICATION FOR DISPENSATION UNDER SECTION 33 OF THE LOCALISM ACT 2011

The Members below have signed a request for dispensations in the following terms:-

#### Taxable Allowances

A dispensation from both the restrictions in section 31(4) to take part and vote in relation to the consideration of a matter in relation to which we have a disclosable pecuniary interest arising through:-

- Any office held within Leeds City Council for which we receive a taxable income; and
- Any office held outside Leeds City Council (to which we have been appointed by Leeds City Council) for which we receive a taxable income.

#### Regulatory Matters

A dispensation from the restrictions in section 31(4)(a) to take part in the discussion of a matter in which we have a disclosable pecuniary interest to allow us to make representations at a meeting where members of the public have the same entitlement (e.g. to allow a Councillor who is making an application for planning permission to attend to make representations at a meeting of the Council's Planning Committee which is to hear the matter in the same way as a member of the public.)
