Approval to award the Bikeability Cycle Training Contract 2023

Brief summary

This report seeks the approval of the Chief Officer (Highways and Transportation) to award the Bikeability Cycle Training Contract 2023 to the preferred bidder following the tender exercise which was carried out via YORtender.

The Contract allows Leeds City Council to provide various levels of cycle training to children in schools within Leeds.

Recommendations

a) The Chief Officer (Highways and Transportation) is requested to approve the award of the Bikeability Cycle Training Contract (the Contract) from 1st September 2023 to 31st August 2025 with the option to extend the contract for a further 2 years to 31st August 2027 to Cycle Leeds Ltd. T/A Cycle North. The total estimated value of the contract including extensions is £2,000,000.

What is this report about?

- Bikeability is the Government's cycle training programme. It is based on the National Standard for Cycle Training and is designed to give the next generation the skills and confidence to ride their bikes on today's roads.
- 2 The Contract allows Leeds City Council to provide various levels of cycle training to children in schools within Leeds.
- 3 Funding for Bikeability is provided via a grant to the Local Authority from the Department for Transport (DfT). Annual funding from the DfT is not guaranteed and future training provision through the contract will only be procured if this external resource is secured.
- 4 The current contract expires on the 31st August 2023 with no further provisions to extend. A full tender process must therefore be undertaken to award a new 2-year contract with the option to extend it for an additional 2 years.

- 5 Approval to tender the Bikeability Cycle Training Contract 2023 was given by the Chief Officer Highways and Transportation on the 16th March 2023 with call-in expiring on the 31st March 2023.
- 6 A tender was published on Yortender on the 5th April 2023 using the open tender procedure and an advert was placed on Find A tender Service (FTS) and Contracts Finder.
- 7 One compliant tender was returned on 10th May 2023.
- The quality submission was assessed on a consensus basis by a panel of Highways and Transportation Officers and this was chaired by an officer from the Highways and Transportation Procurement Team.
- 9 The quality submission scored above the 60% threshold for each method statement question and received full marks for quality based on the weighted evaluation model set out in the tender documents. The financial submission was then opened whereby it also received the full marks based on the weighted price evaluation model stated in the tender documents.
- 10 The one compliant tender was received from Cycle Leeds Ltd T/A Cycle North who successfully passed the quality and price evaluations, they are our preferred contractor.

What impact will this proposal have?

- 11 Continuation of the Contract arrangements and delivery of the associated service will ensure various levels of cycle training to children in Leeds' schools can continue across the City. The use of the tender process and subsequent delivery via the appointed supplier is an efficient and cost-effective method of procuring this service delivery.
- 12 The proposals requested in this report have no impact on the equality characteristics identified in the original equality, diversity, cohesion and integration screening assessment conducted as part of the procurement process. Therefore, it is not applicable to carry out an EDCI impact assessment at this stage.
- 13 The tenderer passed the appropriate questions in the standard selection questionnaire and the social value response to ensure equality and diversity is embedded within their organisation. They also complied with the Equality Act 2010.
- 14 Where considered appropriate an EDCI impact assessment will be carried out by the service responsible for managing the contract and organising the training.

How does this proposal impact the three pillars of the Best City Ambition?

- 15 As set out in Leeds Best City Ambition, Leeds aims to become carbon neutral by 2030. To realise this ambition, the future focus is based upon transforming the way people move around Leeds, with a target to increase cycling usage by 400%. The Bikeability Contract feeds directly into this initiative by teaching the younger generation how to cycle which could help them become confident enough to cycle in and out of the City in future.
- 16 The Contract also links in with Inclusive Grow by teaching children how to ride bikes. This will give them the option to cycle to work when they are older or travel to and from the City via bicycle for any other opportunities that would have otherwise being missed through a lack of inclusion.
- 17 Encouraging more sustainable travel may contribute towards improving air quality and more children travelling more actively may contribute towards better health and wellbeing and promote a healthy lifestyle.
- 18 Initiatives like Bikeability, contribute towards embedding a cycling culture and therefore may contribute towards all three pillars within the Best City Ambition. Giving children experience as on-road cyclists and of how road users interact with each other on the network may also contribute towards them becoming safer road users both now and in the future.

What consultation and engagement has taken place?

What are the resource implications?

- 20 Funding for Bikeability training is provided by the Department for Transport (DfT).
- 21 The Council have received the grant award from the DfT for financial year 2023/24. The amount granted has continued to increase year on year and is now just under £500,000.00.
- 22 The total estimated value of the Contract including extensions is £2,000,000.
- 23 The Council retains a small proportion of the DfT grant to contribute towards the administrative and supervisory assistance that delivery of the Bikeability Cycle Training programme demands of the Council.

What are the key risks and how are they being managed?

- 24 There is no capacity to deliver this service in house therefore outsourcing is the most viable option.
- 25 Funding for Bikeability delivery is provided by the DfT Grant. It is drawn respectively after training has been delivered. Should the contracted provider be unable, for whatever reason, to fulfil its obligations and deliver training to the required numbers, the council would simply not draw down the grant. The financial risk to the council is therefore negligible.
- 26 Annual funding from the DfT is not guaranteed and future training provision through the contract will only be procured if this external resource is secured.
- 27 To maintain continuity in terms of the existing service it is essential that the Contract is awarded before the existing arrangement expires on 31st August 2023.

What are the legal implications?

- 28 There are no specific legal implications arising from this report. All activities relating to the contract award will be executed strictly in accordance with the Public Procurement Regulations 2015 and Councils Contract Procedure Rules.
- 29 The report to tender was published on the List of Forthcoming Key Decisions on the 26th January 2023 with call-in expiring on the 31st March 2023. Awarding the contract is a direct consequence of the initial approval to tender, as such it should be treated as a significant operational decision and is not eligible for call in.
- 30 The report does not contain any exempt or confidential information under the Access to Information Rules.

Options, timescales and measuring success

What other options were considered?

31 No other suitable frameworks were found to be available. It was concluded this was the most cost effective and efficient way to manage this programme of work due to the lead times required to make the necessary arrangements and take advance bookings with schools. This allows the process to be streamlined and manageable in comparison to procuring individual contracts with different service providers for short periods of time.

32 The tender exercise successfully resulted in procuring a suitable and capable supplier within the time frames set out in the initial report to tender and will achieve added value through the social value commitment which the contractor has agreed to.

What is the timetable and who will be responsible for implementation?

33 If the Chief Officer (Highways & Transportation) approves the recommendation to award the contract on the basis it provides best value to the Council. The contract will be in place no later than July 2023 to ensure the preferred contractor can book cycle training sessions with schools for September 2023 onwards.
