Brief summary

- In March 2023, the Adults, Health and Active Lifestyles Scrutiny Board received a report from the ICB Accountable Officer (Leeds Place) that reflected the key priority work areas of the ICB in Leeds linked to the Healthy Leeds Plan, including an update on the work being undertaken to refresh the current Plan.
- Appended to this report is a further update by the ICB Accountable Officer (Leeds Place) setting out the significant progress that has been made since March 2023 and includes a copy of the latest refreshed Healthy Leeds Plan for the Scrutiny Board's attention.

Recommendations

Members are requested to consider and provide any comment on the appended update report from the ICB Accountable Officer (Leeds Place), including the latest refreshed Healthy Leeds Plan.

What is this report about?

- 1 The Healthy Leeds Plan (formerly named Left Shift Blueprint) was signed off in January 2021 as the plan that outlines the Health and Care contribution towards delivering the Health and Wellbeing Strategy, achieving the ambition that Leeds will be a caring city for people of all ages, where people who are the poorest improve their health the fastest.
- 2 Whilst the Healthy Leeds Plan acknowledges that everything is connected and working with teams that focus on the wider determinants of health is essential in achieving health outcomes, it sets out what achieving our shared vision looks like from a health and care perspective.
- 3 It was agreed last year that the Healthy Leeds Plan would be refreshed to coincide with the refresh of the Health and Wellbeing Strategy.
- 4 In March 2023, the Adults, Health and Active Lifestyles Scrutiny Board received a report from the ICB Accountable Officer (Leeds Place) that reflected the key priority work areas of the ICB in Leeds linked to the Healthy Leeds Plan (<u>link to report</u>). This also included an update on the work being undertaken to refresh the current Plan.
- 5 Since the Board's last update in March, significant progress has been made in working with the system, particularly through the Partnership Executive Group (PEG), to bring the work to a successful conclusion.
- The latest position is set out in the appended update report by the ICB Accountable Officer (Leeds Place) and includes a copy of the latest refreshed Healthy Leeds Plan for the Scrutiny Board's attention.

7 Health scrutiny remains an integral part of the Leeds' evolving local health and care system, shaped by the introduction of the Health and Care Act 2022 and the establishment of Integrated Care Boards (ICBs) and Integrated Care Partnerships (ICPs).

How does this proposal impact the three pillars of the Best City Ambition?

8	The current Leeds Health and Well-being strategy sets out the ambition that Leeds will be a
	healthy and caring city for all ages, where people who are the poorest improve their health the
	fastest. The aims of integrated care support many of the strategy's priorities including "the best
	care, in the right place, at the right time".
