I wish to object to the proposed Planning Application, for a supper market at the above address. My objection is based on the following key points.

- 1) lack of parking, the only parking is on the dual carriageway, in the bus lane or outside the residential property across the road.
- 2) the trading times from 6am to 11pm, the residential properties across the road are primarily occupied by OAPs, who will be disturbed by the increase in traffic, parking and footfall early and late in the day.

- I strongly feel that the rate of crime and disorder will increase by having a 4th store selling alcohol on the same road. Also, the stats for the area for March month show a quite significant rise in incidents relating to violent crime (165), shoplifting (63), criminal damage (53), anti-social behaviour (31). These are just a few mentioned.
- I also strongly feel that the public nuisance will increase as there are very limited
 parking spaces for customers to park. This will also lead to public safety if there is
 too much conjunction of cars trying to park and get in/out. There will be car parking
 issues at all times because the dance studio which is a few doors away have the
 parents stay and watch their children perform dance acts, which is why that area of
 the road does tend to get busy with parked cars.

The basis for this opposition is that granting a licence for these premises will not promote the licensing objectives, particularly the prevention of crime, disorder and antisocial behaviour.

It lies within the Council's Cumulative Impact Area, and enabling the premises to sell alcohol would be totally detrimental to its aims and objectives. The application proposes that alcohol will be sold for consumption off the premises between 8:00am and 10:00pm, seven days a week. Granting a licence would provide a further source of alcohol within an area already so heavily populated with licensed premises that crime, disorder and public nuisance have already reached problem levels for the local police.

It lies within the Council's Cumulative Impact Area, and enabling the premises to sell alcohol would be totally detrimental to its aims and objectives. The application proposes that alcohol will be sold for consumption off the premises between 8:00am and 11:00pm, seven days a week. Granting a licence for another shop within the area would provide a further source of alcohol within an area already so heavily populated with licensed premises that crime, disorder and public nuisance have already reached problem levels for the local police. Residents in this area already suffer noise nuisance and antisocial behaviour at all hours of the day and night.

I would also urge the Committee to consider the findings of the Health Impact Assessment, in which evidence of the negative effects of the flexible licensing hours was put forward by local residents

In view of the above, I would urge the Licensing Authority to refuse the application.
