Dear Licensing,

We are writing to object against the application (PREM/05142/001) KASA, 278A Belle Isle Road, Leeds, LS10 3QJ. The area in question has had previous issues with Anti-Social behaviour (ASB), costing the tax payer thousands in initiatives to reduce the issues using a temporary camera, this has recently come to an end and the ASB has started to become an issue again. We believe the 24hour license will not only draw out the ASB into the evening, but it will continue to be an intimidating environment 24/7 in a built-up residential area.

The applicant seems to have done very little, if anything to support the council in dealing with gangs of youths hanging outside the premises, the anti-social behaviour outside or the cleanliness of the street nearby. The owners have failed to gain the support and trust of residents who feel these premises are constant issue.

As councilors we are approached by dozens of objectors to this, but many feel worried their names will be public, so won't object or simply believe their voice doesn't count.

Previously this premises has changed the use of part of their building without permission and only sought permission when told to by council officers – this led to objections and planning permission refused. We feel this shows the character of the business owners and raises alarm bells over any consideration they have for any rules and regulations.

To summarise, we would like to categorically object to any extension of this premises hours.

As a resident living close to KASA, I live in constant fear and caution of this premise as it is a known area for gangs to congregate.


I have raised multiple report with the police around the gangs and in particular the motorcycle/moped gangs who use KASA and the surrounding carparks as a meeting location.

I would like to voice my concerns and TOTALLY OBJECT to the above being granted a 24hr License to sell alcohol.

My main objection is that I live this store and already have constant nuisance noises from the public that visit this store in the hours he already has been allowed. The noise ranges from loud shrieking to loud shouting from members of the public, some already intoxicated at 4.00pm, to dogs barking from shop visitors leaving them outside. There is a constant stream of vehicles that pull up outside this shop with music blaring so loud I can hear it over my TV. If they were granted this license, there will be cars and taxis pulling up at all times of the night, doors slamming, music blaring. Most customers pulling up to the shop would already be at a party that would be prolonged, with their neighbors suffering for longer than necessary. This would have an adverse affect and would just be promoting alcoholism.

At least we have some respite from this when the store closes, so to make this now a 24hr open store is just an absolute nightmare and unfair when my husband and I have to get up early to go to work, which as you are aware, when you have sleep deprivation from nuisance noises during all hours of the day and night, just doesn't bare thinking about. My mental health has already suffered from the way this shop operates, PLEASE can you bare this in mind when you are assessing this application.

We have already had to speak with the shop owner on several occasions regarding noise and this has not changed at all.

This owner has already tried to gain permission (but did operate without one for over a year) to run a brothel underneath these premises and that was thankfully refused. They already have several other companies operating from the rear carpark of this property illegally, namely a roofing company and a gardening/fencing company, as he does not have permission to do this, he has been reported several times in the last few years for this, and apart from a slap on the wrist, seems to be able to get away with what ever he wants to do to the detriment of those who have to live around this shop.

Leeds City Council enforcement officers and the Police have had to attend these premises on many occasions due to violence, fighting with weapons and gangs congregating outside, so if they are planning to sell alcohol 24 hours every day then this would only be promoting this behavior. All of this happens regularly and HAS AN ADVERSE AFFECT ON RESIDENTIAL FAMILIES, so granting a license for this to be 24hrs every day would be promoting an increase in this, causing more mental anguish and anger within the community.

I would like to raise an objection to the above application to sell alcohol 24 hours a day, 7 days a week.

I live in this area quite close to Kasa. This is a residential area with a mixed demographic including children and elderly people.

Kasa provides a good service currently to residents staying open late until 11.00pm, when there is no other shop in the area open until this time.

The location has a decent forecourt and is close to a car park but this does attract groups of people, mainly youths, loitering around outside, sometimes on scooters and bicycles. These groups can be perceived as intimidating to the young and elderly while they are riding around on the pavement blocking the way of pedestrians.

This part of Belle Isle is an area that already has a high crime rate with crimes reported for antisocial behaviour, criminal damage, burglary, drug offences and public order offences, 155 crimes reported to West Yorkshire Police in May 2023.

The availability of alcohol after 11.00pm and into the early hours has the potential to cause litter problems, street drinking, leading to rowdy or inconsiderate nuisance behaviour, antisocial behaviour, and vehicles street cruising, making noise, and alcohol related crimes. For working age people who live in this area this has the potential to disturb sleep.

What if any research has been done to show that there is a demand for alcohol 24/7 in this area?

I would request that whilst my objection is noted, you redact my email address and name.


The entrance to the store is already a congregating area for local youths and believe that anti social behaviour would increase if alcohol was available 24 hours per day.
