As part of the scheme design we have included accessible equipment that will improve play value for children with access needs.

These include:-

• Relocating the play area as it is currently hidden in an area surrounded by trees. Moving the play area to a more visible location will help make it safer and more inclusive for everyone.

- A double seated swing where a parent could sit on one side and a child on the other for children less confident using swings but perhaps too large for the cradle seat.
- A tyre seat swing which a child could placed in and the tyre seat could support the child
- Toddler multi-unit with ground level activities including talk tubes, crawler ramp, play panels and accessible podium steps
- Junior multi-unit with low level activities and an accessible tactile belly seat
- Thermo-plastic markings which provide ground level activities to promote inclusive play regardless of ability and mobility levels
- Accessible roundabout and seesaw springer both with hand support rails
- As part of the project we are planning to either locate the play area near to the car park or along the path at the bottom of the park depending on the outcome of the consultation. Both locations will be more accessible than the current location although the top location would be more accessible in terms of car parking. If the bottom location is chosen we will look into making the entrance more accessible by removing the A-frame and repairing the tree root damage to the path.
