## 2. Please provide a brief description of what you are screening

The Council plans to purchase and provide 30 homes under the Local Authority Housing Fund and to accept the DLUHC grant of £3,329,406 which will part fund the acquisition costs.

The fund will support 21 properties being purchased and allocated to Ukrainian refugee households and 9 properties being purchased and allocated to Afghan households currently in bridging accommodation. Allocations will be made by Leeds Housing Options.

Acquisition of these new council homes directly contributes to delivering the Leeds Best City Ambition pillars of Health & Wellbeing and Inclusive Growth:

- Providing housing of the right quality, type, tenure and affordability in the right places.

- Minimising homelessness through a greater focus on prevention.
- Addressing the challenges of housing quality and affordability, tackling fuel poverty and creating vibrant places where residents have close access to services and amenities.

**How have you considered equality, diversity, cohesion and integration?**

Leeds has a shortage of large family homes. Social housing stock is highly sought after with long wait times; multiple years in many areas for large 3-4 bedroom houses. Private rented routes are expensive and difficult to obtain in the city at affordable rents. Many of the families seeking support through humanitarian schemes originate from the Ukraine or Afghanistan. They require large family homes with 3-4 bedrooms. Delivering additional affordable homes specifically to house 30 of these families will support the city's vision of compassion and commitment to humanitarian schemes.

**Key findings**

The proposal will support an increase in pressure from families who are either in 'bridging accommodation' in the city following the crisis in Afghanistan or families who have fled Ukraine during the war. The proposals will help:

- a) Mitigate the expected increased pressures on local authority homelessness and social housing resources which arise from the eligible cohort as sponsorship/family placements/bridging accommodation arrangements come to an end by increasing the provision of affordable housing available to local authorities to support those in the cohort who are homeless, at risk of homelessness, or in bridging accommodation.
- b) Reduce emergency, temporary and bridging accommodation costs.
- c) Deliver accommodation that as far as possible allows for the future conversion of housing units to support wider local authority housing and homelessness responsibilities to UK nationals (i.e. after usage by this cohort ends).
- d) Utilise accommodation solutions to enable effective resettlement and economic integration of the eligible cohort.
- e) Reduce pressures on the existing housing and homelessness systems and those waiting for social housing.
- f) Should the families who are placed in these homes decide to return to the Ukraine after the 3 year period, these homes will be available to become available to be let in line with existing Housing Leeds stock.

**Actions**

Communities, Environment & Housing and City Development colleagues will work in unison to identify suitable properties in the city.

Resettlement teams and Leeds Housing Options will identify and support families to move into appropriate homes.
