2. Please provide a brief description of what you are screening

The government published the Integrated Rail Plan for the North and Midlands on 18th November 2021. It put the delivery of HS2 to Leeds while proposing a further study is undertaken to look at how to bring HS2 trains to Leeds and Leeds Station Capacity. It also committed to deliver an upgrade to the Leeds-Bradford route, the delivery of the Transpennine Upgrade and core Northern Powerhouse Rail, it also committed to fund the development of a mass transit system for West Yorkshire. Leeds Station will reach capacity at the end of this decade for pedestrian circulation and mid 2030's in respect of the capacity on platforms and tracks.

West Yorkshire requires investment in rail and mass transit to help meet the productivity gap caused by poor connectivity especially rail connectivity between the major cities in Yorkshire and the East Midlands and North East. The IRP accelerates some investment and delays other areas of investment which has an impact on Leeds and its communities.

It is not clear how DfT and Network Rail will engage with local residents, businesses and key stakeholders on the schemes identified in the IRP or when this will happen. Depending on where rail infrastructure schemes are proposed will depend on the impact on communities and whether there is a negative impact on residents and businesses.

By proactively recommending a solution which is phased and prioritises capacity it has the potential to deliver improved connectivity benefits for residents and commuters by the mid 2030's when passenger growth is forecast to increase significantly.

Until the IRP study into how to bring HS2 trains to Leeds has been undertaken there will remain a disparity in rail travel between Leeds and Sheffield.

Key findings

Improving rail connections between Leeds and Sheffield is critical to reducing congestion on the M1 and for enabling people to work in one city and live in another widening economic geographic mobility.

Accessibility issues are increased where platforms become more congested due to lack of capacity and therefore increasing capacity in Leeds Rail Station is important.

The lack of transparency of the rail schemes included in the IRP which have not been consulted on publicly means that communities and residents are unable to raise concerns or help develop solutions which will impact their everyday lives.

Actions

The Council has asked Network Rail and DfT to confirm when local communities and key stakeholders including Ward Members will be consulted on the proposed rail schemes and will continue to discuss this until an engagement plan has been provided.

The rail schemes have the potential to improve accessibility on platforms and the Council will continue to press for accessibility improvements as schemes are identified and consulted on.

The Council will formally send the SLCRail recommendation to DfT seeking its inclusion in the options appraisal for the study into how to bring HS2 trains to Leeds. This will improve public transport connectivity between communities and jobs as early as possible.
