The approval to procure contracts for the supply of personal protection equipment (PPE), workwear & uniforms.

- There is a statutory requirement for the Council to provide PPE to its employees under the PPE at Work Regulations 2022 and the Health and Safety at Work etc. Act 1974.
- In addition to the above statutory obligation the Council also provides clothing and footwear to those employees that are engaged in certain tasks to ensure they have suitable and durable clothing for the type of task they are expected to carry out. This clothing follows a corporate style and carries a Leeds City Council brand identity.
- The Council's current contracts for the provision of workwear and the provision of

PPE are due to expire on 10th April 2024.

- The procurement of new contracts will be awarded following a competitive tender under the Council's Contract Procedure Rules (CPRs).
- The tender specification document will contain a requirement for products to be provided in a fit suitable for all body shapes for both men and women and across a wide range of sizes to meet the needs of all staff.
