Community Right to Bid Nomination for The Sportsman Inn, 14 Hunger Hill, Morley, LS27 9AD

Brief Summary

- In accordance with the Localism Act 2011 (the Act) and the Assets of Community Value (England) Regulations 2012 (the Regulations), this report considers the nomination to include The Sportsman Inn, 14 Hunger Hill, Morley, Leeds, LS27 9AD on the Council's list of Assets of Community Value (ACVs).
- The Council received a nomination from The Friends of the Sportsman Inn which is an
 unincorporated group and eligible to nominate a building or land for inclusion in the Council's
 list of ACVs in accordance with section 89 of the Act. They are eligible to nominate the
 property, but not trigger the moratorium period, bid for the property or legally purchase the
 property. The nomination was received on 20 September 2023.
- As explained in further detail in the body of this Report, it is considered that the Inn satisfies
 the necessary criteria provided for in the Act. As such, it is recommended to the Head of
 Asset Management that the Inn is added to the Council's list of ACVs.

Recommendations

a) The Head of Asset Management is recommended to add The Sportsman Inn, 14 Hunger Hill, Morley, Leeds, LS27 9AD to the list of Assets of Community Value on the basis that the criteria in Section 88(2)(a) and (b) of the Act have been met, and therefore the site is "land of community value".

What is this report about?

- The purpose of this report is for the Head of Asset Management to consider whether The Sportsman Inn, 14 Hunger Hill, Morley should be included in the List of Assets of Community Value or whether it should be included on the List of Land Nominated by Unsuccessful Community Nominations in accordance with Part 5 Chapter 3 of the Localism Act 2011.
- 1.2 Part 5 Chapter 3 of the Localism Act 2011 and the Assets of Community Value (England)
 Regulations 2012 contain the rules relating to "Assets of Community Value" and the related
 "Community Right to Bid". The purpose of these legislative provisions is to give communities
 a right to identify a building or land that is believed to further the local community's social
 wellbeing or social interests, such that it may be added to the Council's list of ACVs. Once

listed, the legislation further gives an opportunity for communities to make a bid to purchase the building or land on the open market if the owner decides to sell. From the date the landowner informs the Council of their intention to sell "community interest groups" as defined in the Regulations have a period of six weeks to request in writing for the group to be treated as a potential bidder in relation to the land. If they do make such a request, the owner is prevented from disposing of the property for a period of six months (from the date they originally informed the Council of their intention to sell) unless it is to a community interest group. The landowner is free to dispose of the property at the end of the six month period to whomsoever they see fit.

- 1.3 Section 90 of the Act states if a local authority receives a "community nomination" for a building or other land to be included in the list of ACVs, the authority must consider the nomination. The authority must accept the nomination if the land nominated is in the authority's area and is of community value.
- 1.4 The site is located within the Morley South ward (please see the red line boundary plan at Appendix 1) and therefore falls within the Council's area. Ward Members have been made aware of the nomination. No responses have been received.
- 1.5 The nomination includes the property, The Sportsman Inn, the car park and the beer garden.
- 1.6 The freehold interest in the property is owned by Admiral Taverns Ltd. The Sportsman Inn has ceased trading as a public house having been closed since March 2023. The decision was made to cease trading as a public house as Admiral Taverns felt that it did not have a long term sustainable future.
- 1.7 On 13 November 2023, the case officer contacted the landowner, Admiral Taverns to seek clarification as to whether the property is currently being marketed for disposal or whether a purchaser has been secured. Admiral Taverns have confirmed via email on 15 November 2023 that they have no comments to add in relation to the nomination and that is their intention to sell the property in the future and are therefore aware of the implications on any future sale should the property be listed. The Council therefore considers that no 'relevant disposal' (as per s95 and s96 of the Act) has commenced.
- 1.8 The nominator has advised that The Sportsman Inn has been a viable public house for over 130 years. When trading it was enjoyed by many local families for regular community activities such as games evenings, live music events, charity fundraising events and seasonal events such as easter egg hunts and barbecues.
- 1.9 The nominator has also advised that the Sportsman Inn was previously a venue used by Morley Borough Rugby League teams and cycling groups.
- 1.10 For property or land to be included in the List of Assets of Community Value, the nominator must be able to demonstrate and satisfy all the listing criteria as laid down in the legislation. Section 88 of the Act provides for when land is to be regarded as 'land of community value'. Section 88(1) of the Act states that buildings or land with a current use is considered to be of community value, if, in the opinion of the authority, there is:
 - a) an actual current use of the building or other land that is not an ancillary use which furthers the social wellbeing or social interests of the local community.
 - b) It is realistic to think that there can continue to be non-ancillary use of the building or other land which will further (whether or not in the same way) the social wellbeing or social interests of the local community.
- 1.11 For buildings or other land that do not have a current use, the legislation (section 88(2) of the Act) states that land is of community value, if in the opinion of the authority:

- a) there is a time in the recent past when an actual use of the building or other land that was not an ancillary use furthered the social wellbeing or interests of the local community, and
- b) it is realistic to think that there is a time in the next five years when there could be non-ancillary use of the building or other land that would further (whether or not in the same way as before) the social wellbeing or social interests of the local community.
- 1.12 It is evident that the Sportsman Inn has previously been a popular and important venue and used by the local community for many years having been fully open and trading within the last 12 months, which is the recent past. It has not been closed for a lengthy period of time and so ostensibly the demand and uptake for this facility by the local community remains, as evidenced by the nomination. The property is going to be sold by the existing commercial tavern/ pub operator and so there is every reason to think it could continue in this use in the future.
- 1.13 Therefore, it is considered that the criteria for listing as set out in Section 88(2) of the Localism Act 2011 have been met and the nominated building / land should be added to the List of Assets of Community Value.

Morley South ward members have been informed of the nomination. No comments have been received.

What are the resource implications?

- 5 The consideration of the application for listing and listing process are carried out within the Council's existing staff resource.
- The Localism Act contains a right for the owner of land included in a local authority's list of ACVs to ask for the authority to review its decision to include the building / land in the list (section 92). If a local authority upholds its decision to list, and the landowner is still dissatisfied following the listing review, it may appeal to the First-Tier Tribunal. If the Tribunal finds in the landowner's favour on appeal, there could also be an award of costs against the Council.

The Act also gives the owner a right to compensation if they incur costs or loss of value directly from complying with the legislation. Any compensation would be payable by the Council.

What are the key risks and how are they being managed?

7 There are no specific risks which arise resultant from this decision. However, the above risk is to be noted in terms of the possibility that the decision to list the Inn could be subject to a review request by the owner.

What are the legal implications?

The City Solicitor confirms that the conclusions and recommendations in this report represent a reasonable and proper application of the statutory criteria for determining whether the nominated building / land can be regarded as 'land of community value' and, as such, should be added to the Council's list of Assets of Community Value.

The Head of Asset Management has authority to take the decision requested in this report under Executive functions 2(o) (specific to the Director of City Development) of the Director of City Development's sub delegation scheme.

The proposal constitutes a significant operational decision and is therefore not subject to call in.

Options, timescales and measuring success

What other options were considered?

9 This is a procedural matter and the only options are to list or not list the property as an Asset of Community Value. The considerations set out in this paper provide justification for the recommendation being made.

What is the timetable for implementation?

10 Upon approval of this report, the property will be added to the list of Assets of Community Value.
