Name and Address of Premises: 25 - 27 Thornleigh Mount, Cross Green, Leeds, LS9 8QW.

The application premises are located at the end of a terrace of back-to-back type properties (with a flat above and a house adjoining to the rear) in a predominately residential area of Cross Green. The existing licence is for off sales of alcohol from 08:00 hours to 21:00 hours 7 days a week. This variation application is to increase those hours to 24 hours a day 7 days a week. No mitigation has been provided to ensure that the prevention of public nuisance objective will be met.

There is potential for noise disturbance from customers and delivery drivers arriving and leaving to collect or purchase alcohol extremely late at night and into the early hours of the morning causing sleep disturbance. The hours applied for will be an increase in the potential for noise and antisocial behaviour without much respite. For example, the residents may be subject to increased noise from vehicles and people visiting the business, raised voices, car stereos, car doors banging. Patrons leaving the nearby Social club may also be minded to buy further alcohol after closing from these premises as opposed to going home which may lead to drunken anti-social behaviour in the street.

Allowing this variation could set a precedent for other similar businesses exacerbating the potential of public nuisance to the area.

Although I appreciate that the business would like additional hours for trading it is our view that those applied for are excessive for this location. Also, the applicant has not provided any mitigation measures as to how this extension to the trading hours and licensable activity would not cause public nuisance. We would therefore propose a more modest increase in off-sales trading hours.

Having considered the application under the Licensing Act 2003 for the above premises, we consider that the following measures are relevant and reasonable in order to meet the following aim of the licence:

· Prevention of public nuisance

- The opening hours and hours for the sale of alcohol shall be 07:00 hours to 23:00 hours.
- 2. The PLH/DPS shall ensure that litter arising from people using the premises is cleared away regularly and that promotional materials such as flyers do not create litter.
