Summary of Main Issues

This is an application for the grant of a premises licence made by Versa (Whitehall Road) Limited, for Stage 4, Versa Studios, Whitehall Road, Leeds, LS12 1AP.

The application describes the premises to act as Film and TV studio space and multi-use event space.

Responsible authorities and Ward Members have been notified of this application.

Discussions with West Yorkshire Police have resulted in an amendment to the condition regarding the minimum retention period of CCTV footage.

The application has attracted an outright representation from Leeds City Council's Environmental Protection Team and negotiations have been unsuccessful. The representation remains a matter outstanding for the Sub Committee's consideration.

1 Purpose of this Report

- 1.1 To advise Members of an application made under section 17 of the Licensing Act 2003 ("the Act") for a new premises licence in respect of the above mentioned premises.
- 1.2 Members are required to consider this application due to the receipt of representations.

2 History of the Premises

2.1 This is the first application for a premises licence for these premises.

3 The Application

- 3.1 The applicant's name is Versa (Whitehall Road) Limited.
- 3.2 The proposed designated premises supervisor is Alexander Webb-Ingall.
- 3.3 In summary the application is for:

Sale by retail of alcohol, Performance of a play, Exhibition of a film, Performance of live music, Performance of recorded music, Performance of dance & Entertainment similar to live music, recorded music or dance

Sunday	09:00 - 01:00

Late night refreshment

Non standard timings:

From the start time on New Year's Eve to the terminal hour for New Year's Day.

On the day that British Summer Time commences, one additional hour to disapply its effect.

- The applicant proposes to promote the licensing objectives by taking the steps identified in the separate operating schedule attached at **Appendix B**.

4 Location

4.1 A map which identifies the location of the premises is attached at **Appendix C**.

5 Representations

5.1 Under the Act representations can be received from anyone but they must be relevant and, in the case of a member of the public, must not be frivolous or vexatious.

Representations from Responsible Authorities

- Not considered a formal representation to the application discussions between the applicant and West Yorkshire Police have resulted in an amendment to the operating schedule, namely the minimum retention period of CCTV footage will be 31 days, rather than 28 days as proposed originally. A copy of the e-mail may be found at **Appendix D**.
- 5.3 An outright representation submitted by the Environmental Protection Team remains a matter for Members' consideration. A copy of the representation may be found at **Appendix E**.

Other representations

5.4 There are no other representations.

6 Licensing Hours

- 6.1 Members are directed to paragraphs 6.8 to 6.15 of the Statement of Licensing Policy which states the criteria that will be applied to any decision for new applications or variations which include extending hours.
- In brief the Policy states at 6.14 that restrictions may be made to the proposed hours of use where, after receiving relevant representations, the council considers it appropriate for the promotion of the licensing objectives to do so.
- 6.3 The council will take into account the existing pattern of licensed premises in an area when considering what is appropriate to promote the objectives. Applications which are significantly out of character for a locality will need to demonstrate that granting the hours sought will not adversely impact on the licensing objectives.
- A list of premises in the local area and their licensed hours and activities is provided at **Appendix F**.

7 Equality and Diversity Implications

7.1 At the time of writing this report there were no implications for equality and diversity. Any decision taken by the licensing subcommittee will be in accordance with the four licensing objectives as prescribed by the Licensing Act 2003.

8 Options Available to Members

- 8.1 The licensing subcommittee must take such of the following steps as it considers appropriate for the promotion of the licensing objectives:
 - Grant the application as requested.

- Grant the application whilst imposing additional conditions and/or altering in any way the proposed operating schedule.
- Exclude any licensable activities to which the application relates.
- Refuse to specify the said person as the designated premises supervisor.
- Reject the whole or part of the application.
- 8.2 Members of the licensing subcommittee are asked to note that they may not reject the whole or part of the application merely because they consider it desirable to do so. It must be appropriate in order to promote the licensing objectives.
