The Community Home Care Service contract is due to expire on 31<sup>st</sup> March 2024 after previously being extended in 2021, 2022, and 2023 from its originally intended end date. Now we feel it is necessary to procure a new contracting arrangement with the home care market in Leeds in the interim period whilst a new model of home care is piloted as part of the Community Health and Wellbeing Service. This will provide a more equal footing for providers across the city to be able to meet home care demand.
