<b>Decision details<sup>3</sup>:</b>	<p>The Chief Planning Officer has agreed that the above Tree Preservation Order will be confirmed as per the report of the City Solicitor (Corporate Governance).</p> <p>This function is sub-delegated to the Deputy Chief Planning Officer or Head of Planning Services under the Chief Planning Officer's Sub-delegation Scheme (Hedgerows and Trees).</p> <p style="margin-left: 40px;">a) Having carefully considered the issue raised by the tree owner, on balance it is considered that the Tree Preservation Order is warranted on the grounds of amenity and expediency.</p> <p style="margin-left: 40px;">b) That the Order be confirmed, as originally served.</p> <p>A Conservation Area notification under s.211 of the Town and Country Planning Act 1990 (Ref: 23/05682/TR) was received by the Council. Proposed works to a Birch tree were considered excessive and detrimental to tree condition and amenity value. Birch tree meets the criteria for a TPO under TEMPO.</p>


