The decision to vary the contract with The Appropriate Adult Service (TAAS) for the West Yorkshire Appropriate Adult Service.

The commencement date is the 1st April 2024 for 12 months, with the option to extend for 6 months. The contract value is £270,000.

The variation ensures the service is able to respond to the increasing demand for appropriate adults across West Yorkshire. The service ensures that provision across West Yorkshire is equitable and provides improved opportunities for partners including West Yorkshire Police to better link into the service and improve provision for those most in need (vulnerable adults and young people in custody) as well as the volunteers who support them.

TAAS responds to requests from West Yorkshire Police for an appropriate adult (AA), when a parent or guardian is unable to be present.

The Local Authority has a statutory duty to provide an Appropriate Adult for young people who are held in Police Custody. There is also a need to provide support to adults who are identified as vulnerable.

This includes working with local systems to promote the use of those who know the service user best.
