The authority has a statutory duty to make provision for this child who has an Education, Health and Care (EHC) Plan.</p> <p>It is considered in the public interest that information contained in the business case is exempt from publication as it relates to a vulnerable child or young person within the City and the actions taken are to enable that person to receive their statutory entitlement to a minimum of 25 hours of education.</p> | | |
