Through the process of developing the proposals for a new playground at Lotherton, we have consulted colleagues and partners across the Council including the EDCI group and play professionals in the Green Spaces team, the Lotherton project board including Museums and Galleries colleagues, the Planning team via the Pre-App process and the Council's Disability Officer.

We also consulted a wide range of design guidelines for play including those produced by Play England and PIPA (Plan for Inclusive Play).

Following this work, it was made clear in the project brief provided with the tender documents, that accessibility and EDCI are a key element of the work and the tender evaluation process included assessing tenders on 2 criteria related to EDCI – one asking how the contractor would meet the Council's requirement to provide a wide range of 'play experiences' for all age groups under 14 and the other asking how they will ensure compliance with BS8300, so that children with special educational needs and disabilities can enjoy the facilities and parents/carers with disabilities can access the site.

In their tender, Greenspan Projects Ltd met the brief and the specific tender criteria relating to EDCI,

We aim to provide play facilities at Lotherton that are accessible and able to be enjoyed by children of all backgrounds, interests and abilities. To make sure this happens throughout the next stages of the scheme we will:

- Work with the successful contractors to ensure physical accessibility and a range of play equipment suitable for children of all ages, background, interests and abilities is an integral part of the design process.
- Follow BS8300 and the PIPA design guidelines
- Take into consideration physical access to the play facilities and surrounding areas for parents and carers.
- Take into consideration findings of earlier consultations into what local families with special educational needs and disabilities think of playgrounds in Leeds and how they can be improved.
- Undertake a public consultation (including with families with special educational needs and disabilities) to ensure the designs are accessible, exciting and provide enjoyable experiences for all children.
