Part 4 – Details of association of the above premises with serious crime, serious disorder or both (please read Guidance note 2)

On the 18<sup>th</sup> May 2024 at 23:00, A serious assault took place which was committed by the Premises Licence Holder and Designated Premises Supervisor Dane Smith.

The victim and his friends were in the premises that day consuming alcohol leading up to this offence. They are 17 years old which constitutes a serious breach of the licensing objectives to protect children from harm. Selling children alcohol is in itself an offence under the licensing act.

Dane Smith confronted the victim and his friends after discovering a pool cue had been snapped. During the conversation, Smith is described to have "snapped" and hit the victim with the snapped pool cue causing a gash to the victims eye brow around 20mm wide and 10-15mm deep. This required hospital treatment. This has been classified as a section 18 assault which is a serious offence.

Dane Smith was interviewed and fully admitted the offence and offered no defence to his actions. He states he is struggling with mental health issues and is under too much pressure and stress to cope.

We have serious concerns that there may be further acts of violence by the Premises licence holder and designated premises supervisor Dane Smith if he is allowed to remain in place. Given the severity of the incident, it is necessary to seek to revoke the licence immediately given Smith is both the licence

  - 'Conduct that amounts to one or more criminal offences and involves the use of violence, results in substantial financial gain or is conduct by a large number of persons in pursuit of a common purpose;
  - Serious disorder is not defined in legislation and so bears its ordinary English meaning.
