Part 4 – Details of association of the above premises with serious crime, serious disorder or both (please read Guidance note 2)

This is an application for a summary review on the grounds of involvement in serious crime with both substantial financial gain and conduct by a large number of persons in pursuit of a common purpose.

The background to this is that Gusto formerly traded as Baba Jaga 2.

On the 16th June 2023, quantities of non duty paid alcohol, an illegal vapes, tobacco and cigarettes were seized from the premises after a joint operation by West Yorkshire Police, Leeds City Council Licensing, Trading Standards and HMRC.

On the 10th July 2023, Trading Standards conducted a test purchase at the store and were sold cigarettes at £4, well below a price possible to account for the correct UK tax duty to be paid.

Previous test purchases of illicit cigarettes were made by trading standards on the 20th September 2021, 28th September 2021 and the 24th April 2023.

On the 13th September 2023, West Yorkshire Police carried out a test purchase operation. A child was sold alcohol on the shop.

As a result of the above, West Yorkshire Police submitted an application to review the licence for Baba Jaga 2 due to the licensing objectives not being upheld. The required notices for the review application were posted outside the shop on the 18th October 2023.

The next day on the 19th October 2023, Gusto Mini Market Ltd was incorporated and registered to the shop address at 12-14 Strathmore Drive. An application to change the premises licence holder and designated premises supervisor was then submitted on the licensing on the 24th October 2023.

West Yorkshire Police objected to the transfer on the basis that it was believed this was not a genuine transfer, but an exploitation of a loop hole, to negate the licence review to allow it to continue to trade and continue its serious illegal activity. West Yorkshire Police were concerned this was just a paper exercise and that the premises would operate in the same manner.

A Hearing took place on the 5th December 2023 to decide on the transfer application. The transfer was approved by the committee. The premises licence review for Baba Jaga 2 subsequently took place and the licence was allowed to continue in Gusto Mini Market Ltd's name.

On the 18th April 2024, a joint operation was carried out at Gusto Market with trading standards and other agencies. During the visit, 2 males were seen to jump out of the flat windows located above Gusto. Officers gained entry to the flat and recovered a substantial amount of illicit and illegal vapes and cigarettes from the flat along with large amounts of cash. Evidence located in the flat showed that the goods were believed to have been stored for Gusto, and to be sold in Gusto. Walkie Talkies were present in both the store and the flat suggesting levels of sophistication and organisation to carry out this operation.

This is exactly the same criminal behaviour seen when the premises was Baba Jaga 2, and confirms the concerns of West Yorkshire Police that the transfer was not genuine and there would be a continuation of criminality at the premises.

The sale of illicit tobacco and vapes occurs in a number of shops in the area. This activity requires large amounts of goods to be smuggled from Eastern Europe and beyond requiring a number of people to be involved in pursuit of a common purpose. This is believed to be organised crime that results in substantial financial gain.

The standard review process has not been either effective or of sufficient deterrent and therefore necessitates a summary review as part of a stepped approach. The premises is failing to uphold the licensing objectives and this review is necessary to protect public safety, prevent serious crime and disorder and to protect children from harm. West Yorkshire Police respectfully ask the committee to consider an immediate suspension as an interim step.

Notes for Guidance
