# Part 4 – Details of association of the above premises with serious crime, serious disorder or both (please read Guidance note 2)

On 19th May 2024 at approximately 0050 hrs, a large-scale disorder occurred at the New Middleton club involving a number of youths, grown males and females. The incident was captured on Leeds Watch and shows older children on push bikes and scooters riding up and down the street outside the venue as a crowd of approximately 30 people exit the premises where multiple fights ensue in the street and at the entrance to the property. At approximately 0053 hours, a male is seen walking across the road towards the venue carrying something heavy in his hand. He approaches the crowd and proceeds to hit someone around the head with the item (believed to be a gas cannister). This has caused multiple serious injuries including a bleed on the brain, a broken cheek bone and other facial injuries to the victim, a male who had been trying to break up one of the fights.

Police found at the scene; pools of blood, a broken Budweiser bottle with its contents visibly spilled on the path, a sledgehammer in the men's toilets; a tea towel covered in blood and a pink balloon cannister. The car park was littered with numerous other gas cannisters and balloons according to an Officer at the scene.

The premises licence for the New Middleton states the opening hours are everyday between 1100-2330 hrs. Therefore, this incident occurred whilst they were open beyond their permitted hours. Entertainment Licensing have confirmed that no Temporary Event Notice had been applied for and therefore the venue was operating without any authorisation in place.

Historically this venue had its premises licence reviewed in 2020 by Leeds City Council when Julie Jackson was running the venue. West Yorkshire Police supported the Council's review. The licence was revoked at this time

due to anti-social behaviour, assault, disorder involving multiple people, unruly children and serving beyond permitted hours alongside a high number of continuous breaches of the premises licence.			
In 2022 a new licence was applied for by Tanya Clowes and was granted despite representations by West Yorkshire Police.			
When the police attended this incident on 19th May, Tanya Clowes, stated to the Officer that the pub. At the hearing in 2022, a condition was put on the licence that David Jackson (now deceased) was to not be involved with the pub. It is believed that The Jackson family had no regard for their premises licence back in 2020 and seems that nothing has changed since that time despite revocation and supposedly "new" management in place in 2022. They own the building itself.			
The incident on the 19 <sup>th</sup> May alone demonstrates serious crime and disorder being linked to the premises. West Yorkshire Police have concerns that whilst these premises are open and operating, public safety cannot be maintained, children cannot be protected and there are fear of reprisals due to the people involved in the disorder all being local to the area.			
In addition to the above and with both the Leeds United Playoffs and the Bank Holiday this coming weekend West Yorkshire Police ask the Licensing Sub-Committee to consider immediate suspension of the premises licence until the review proper.
