# Brief summary

A Tree Preservation Order ("the Order") was made in respect of the above site on 11 January 2024 a provisional basis.

Under the Town and Country Planning (Tree Preservation) (England) Regulations 2012 the Order will expire if it has not been determined within 6 months of the date of making.

Two objections to the Order were submitted by two Agents on behalf of the landowner.

Additional email correspondence between the landowner, landowner's Agent, Legal Officer, Landscape Officer is appended as requested by the landowner.

The Chief Planning Officer is requested to determine whether or not the Order should be confirmed, or alternatively confirmed subject to additional modification, in light of the objections.
