Brief summary

This report sets out the reasons for recommending that the Chief Officer Highways and Transportation should approve this request to award the Mobile Elevated Working Platform Framework 2024.

The current Mobile Elevated Working Platforms contract will expire on the 14^{th of} July 2024 with no provisions to extend. A replacement framework is required for the Council to be able to hire mobile elevated working platforms for inspecting bridges and structures at height without the use of scaffold access.

Recommendations

a) The Chief Officer (Highways and Transportation) is asked to approve the recommendation to award the Mobile Elevated Working Platform Framework 2024 to Access Hire Nationwide Ltd and Tracked Access Platforms Ltd with a potential value of £160,000 over a 4-year period from the 15th July 2024 to 14th July 2028.

What is this report about?

- 1 The Council being the Highway Authority has a statutory duty to ensure that highway structures are maintained for reasons of public safety under the Highways Act 1980.
- 2 This framework is for the provision of various types of mobile elevated working platforms with or without a supplied operator.
- 3 This framework is necessary to enable staff to carry out "touching distance" inspections of bridges and structures.
- 4 This will be a four-year framework, awarded to all compliant tenderers, there will be no quality or price evaluation, other than to vet the tenderer's company details and the validity of the suppliers' rates.
- 5 An open tender was advertised on the councils e-tendering platform YORtender and Contracts Finder on the 30th April 2024.
- 6 The council received two tender submissions by the return deadline of the 29th May 2024.

- 7 The two submissions were evaluated based upon their schedule of rates and Standard Selection Questionnaires to ensure they were compliant.
- 8 After the evaluation, it was established that both were compliant and it is recommended the framework agreement is awarded to Access Hire Nationwide Ltd and Tracked Access Platforms Ltd.
- 9 Suppliers will be given the opportunity to submit revised rates annually using the Consumer Price Index (CPI).

What impact will this proposal have?

10 Due consideration has taken place as part of the Corporate Procurement process, and it is currently not applicable for an Equality, Diversity, Cohesion and Integration screening / impact assessment to be undertaken at this time.

12 Consultation was undertaken at pre-tender stage with the Bridges Section who have confirmed their need for this framework and the Finance Section who confirmed that funding would be available through the Bridges revenue budget.

What are the resource implications?

- 13 The award of this framework is an efficient use of Council resources and is judged to be value for money in comparison to issuing tenders or orders for each individual work instruction.
- 14 The estimated value is £160,000 over the 4-year life of the framework.

What are the key risks and how are they being managed?

15 This Framework will ensure that the Bridges Section will be able to continue to carry out routine or emergency high-level inspections of bridges and structures in an efficient and cost-effective way.

What are the legal implications?

16 There are no specific legal implications arising for this report and all activities relating to the award of this contract are being conducted in accordance with the Council's Contracts Procedure Rules, CPR 9 – Over £100K High Value Procurements.

Options, timescales and measuring success

What other options were considered?

17 The award of this framework is an efficient method of providing the Bridges Section with the plant hire resource which is essential to their service.

How will success be measured?

18 The procurement exercise has resulted in the retention of two of the incumbent contractors from the last framework. These suppliers have given many years of good service to the council and the rates submitted represent good value for money.

What is the timetable and who will be responsible for implementation?

19 The current contract expires on the 14th July 2024, the Highways Procurement team will aim to have the new framework in place to commence on the 15th July 2024 to provide continuity in the service.
