2. Please provide a brief description of what you are screening

The decision to procure Targeted Short Breaks through a competitive grants process.

Current arrangements are going to cease at the end of September 2024. Issuing grants through a competitive process will ensure this support remains in place for C&YP with SEND and their families/carers from the 1<sup>st</sup> of October 2024 with no gap in service.

In collaboration with parents and carers, the Commissioning Team is transforming the Short Breaks offer in Leeds, starting from 1st October 2024. The transformation will be implemented incrementally, with some changes occurring immediately and others within 12 to 18 months. This approach will allow time for the changes to be embedded into services that will be vital to the new model, such as the Early Help and CHAD teams. During this period, the commissioning team will work with providers to identify alternative sources of income and become self-funded.

The purpose of this competitive grant process is to ensure children, young people, parents and carers' needs are met while maintaining high quality and varied targeted short breaks offer for C&YP with SEND in compliance with the principles of the Children and Families Act 2014. The total value will be no more than £317,500 per annum.
