2. Please provide a brief description of what you are screening

The council Housing Growth Programme is currently working towards a challenging target to deliver 1,230 new Council homes across the city by March 2025.

This is being achieved through a combination of building new council homes and acquiring existing properties which are refurbished under the Property Acquisitions Programme. The properties being acquired are predominantly former council homes which were bought under the Right To Buy regime, including those of which the statutory Right of First Refusal regulations apply.

The council commenced work on this new 'buyback' project in late 2018 and is now ready to progress further re-purchases. Once refurbished, these properties will be reintroduced to council housing stock to be let to council tenants.

Acquisition of these new council homes directly contribute to delivering the Leeds Best City Ambition pillars of Health & Wellbeing and Zero Carbon by:

- Providing housing of the right quality, type, tenure and affordability in the right places.
- Minimising homelessness through a greater focus on prevention.
- Addressing the challenges of housing quality and affordability, tackling fuel poverty and creating vibrant places where residents have close access to services and amenities.
