CITY OF LEEDS TREE PRESERVATION ORDER (NO.16) 2024 TPO 2024 16 (WESTFIELD GROVE 78 ST MICHAELS ROAD HEADINGLEY LEEDS LS6 3BG)

Brief summary

- A Conservation Area notification under s.211 of the Town and Country Planning Act 1990 (Ref: 24/00528/TR) was received by the Council on 29 January 2024, to crown raise a Lime tree by an additional 3m from ground level (to f
- A Leeds City Council (LCC) Tree Officer visited site 14 February 2024. The proposed works were considered to be detrimental to the condition and amenity value of the tree.
- It was deemed expedient for the Council to serve a Tree Preservation Order ('TPO') on the site, which was made on 05 March 2024
- Under the Town and Country Planning (Tree Preservation) (England) Regulations 2012 the Order will expire if it has not been determined within 6 months of the date of making.
- An objection to the Order were submitted by the homeowner on 31 March 2024. The
 objection was based the species of the tree, the potential impact on sale of the
 property, and the risk associated with the tree.
- The Council responded to the objection on 10 June 2024. No further comments have been made by the objector.
- The Chief Planning Officer is requested to determine whether or not the Order should be confirmed, or alternatively confirmed subject to modification, in light of the objection.

Recommendations

- a) Having carefully considered the issue raised by the tree owner, on balance it is considered that the Tree Preservation Order is warranted on the grounds of amenity and expediency.
- b) That the Order be confirmed, as originally served.

What is this report about?

- 1 To set out the background to the making of the provisional Tree Preservation Order and to note the fact objections to the Order has been submitted to the Council.
- 2 To seek a determination from the Chief Planning Officer that the Order be confirmed.

- 6 A minimum statutory objection period of 28 days applies in respect of any Order made

9 The Chief Planning Officer is authorised to take the decision whether to determine Tree Preservation Orders under Part 3 Section 2A of the Constitution (Council non-executive functions).

- 10 It is necessary to balance the rights of the landowners against the public interest in the protection of trees provided for by the statutory provisions. Local Planning Authorities have the powers to make Tree Preservation Orders if it appears to be expedient in the interests of amenity to make provision for the preservation of trees or woodlands in their area.
- 11 The amenity of the tree(s) is considered on balance to justify the making confirmation of a Tree Preservation Order and to outweigh the rights of the property owner(s) to manage trees without local authority control.
- 12 The objection of Ms Hazel Savage dated 23.03.2024 (received 31.03.2024) is exempt from publication under Access to Information Rule 10.4(2).

How will success be measured?

14 The trees identified for retention within the Order, make a significant contribution to the "green" character of the street and to the local quality of the surroundings.

What is the timetable and who will be responsible for implementation?

15 The Tree Preservation Order will be confirmed, as soon as possible, and by 05 September 2024, at the latest, should the Chief Planning Officer determine that the Order should be confirmed on this basis.
