This assessment is screening the request to approve the request to utilise the extension period of up to 24-months in the 24/7 onsite care presence and the provision of care and support at Wharfedale View contract delivered by Roche Homecare Limited, formerly Roche Healthcare Ltd. The request is to utilise the full 24-months available to accommodate a service review and the ensuing procurement activity following this.

Extra care housing is a form of supported housing. It is usually designed to provide older people who have varying levels of care needs with a self-contained home and access to on-site care and support. While the service is based at a named site, access to the service is citywide and open to all citizens of Leeds who meet the eligibility criteria. This criteria normally includes a level of assessed eligibility based on an individual's circumstances and has itself been subject to equality screening as a function.
