## 2. Please provide a brief description of what you are screening

The proposed expansion of Broomfield South SILC is being considered to meet an acute shortfall in Special Educational Needs and Disabilities school places in south Leeds.

The project would expand the school from 180 to 280 pupil places. It would involve a substantial new build school, a link to an existing building on site, extensive external works and demolition of several end-of-life buildings on site, including the current main school building.

A screening exercise has been carried out to determine if the acceptance of a fee proposal from Norfolk Property Services and an approval to incur expenditure to progress RIBA 2 will impact upon equality. The main scheme design and cost report/EDCI will set out the full scope of works therefore this decision does not impact on equality.
