2. Please provide a brief description of what you are screening

This screening relates to the acceptance of grant funding from the Office of Health Improvement and Disparities to fund specialist support for individuals to access and engage with drug and alcohol treatment and move towards longer-term accommodation, supporting the work of wider homelessness and rough sleeping funding.

Since 2021, the Office of Health Improvement and Disparities (OHID), in partnership with the Department for Levelling Up, Housing & Communities (DLUHC), has provided funding to local authorities to fund specialist support for individuals who are, or are at risk of, rough sleeping, to access and engage with drug and alcohol treatment and move towards

longer-term accommodation, supporting the work of wider homelessness and rough sleeping funding. The allocation for 2024/25 is £756,327.
