2. Please provide a brief description of what you are screening

This screening relates to the expenditure of grant funding from the Office of Health Improvement and Disparities to fund specialist support for individuals to access and engage with drug and alcohol treatment and move towards longer-term accommodation, supporting the work of wider homelessness and rough sleeping funding.

Leeds City Council has a contract with Humankind Support Services Limited to deliver the Integrated Drug & Alcohol Service (61854). In previous years the grant has been included in this contract to establish a dedicated team including street-based recovery co-ordinators, outreach activity, psychological support, specialist therapeutic outreach workers and a ring-fenced budget for in-patient detoxification and / or residential rehabilitation. Therefore, approval is being sought to change the contract value to include an additional £756,327 for the period of 1st April 2024 to 31st March 2025 to continue this activity.
