The UK Shared Prosperity Fund (UKSPF) based on current guidance from government. The prospectus for the UKSPF was launched on 13 April 2022 by the Government's Department of Levelling Up, Housing and Communities. The UKSPF provides £2.6 billion of new funding for local investment between April 2022 and March 2025, with all funds required to be spent by March 2025.

As Leeds is part of a mayoral combined authority West Yorkshire Combined Authority (WYCA) are the lead local authority for the region and as such hold responsibility for the delivery of the programme with the Government.

As part of WYCA's process for distributing the funding Leeds City Council was allocated £9,393,528 to be deliver hyper-local activity in February 2023. In October 2024 the Council was allocated additional funding (£265,391) to deliver additional activity.
