The premises historically operated as a takeaway venue; however, my client has recently taken over the premises and now wish for the site to benefit from late-night refreshments. The premises is situated within an industrial area with minimal residents nearby, the premises will operate solely as a late-night food delivery venue with absolutely no alcohol. The premises will primarily be a delivery only venue. Please see additional sheet for further information and conditions.

### b) The prevention of crime and disorder

1. A CCTV system will be in operation at the premises at all times when it is being used for the provision of licensable activities. The CCTV system will record images to cover all areas of the premises to which the public have access, save for toilets. The CCTV system will be capable of retaining images for a minimum of 14 days, will be of good quality and will be correctly time and dated stamped. CCTV will be made available on request to an authorised officer.

#### c) Public safety

    - a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
    - a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
    - a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
    - a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
    - a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.

  - o any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
  - o any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
  - any entertainment (excluding films and a boxing or wrestling entertainment) taking
    place at a travelling circus, provided that (a) it takes place within a moveable structure
    that accommodates the audience, and (b) that the travelling circus has not been
    located on the same site for more than 28 consecutive days.
