

CASTLEGATE LEISURE

HISTORY

Castlegate Leisure was created in 2003 with the opening of the Reform Bar on Merrion Street, Leeds. The Reform Bar provides an eclectic mix of music with an extensive range of cocktails, wines and champagnes (see appendix 1 and 2). Current hours Monday to Sunday 11:00 to 04:30.

Following on Reform's success as an upmarket cocktail lounge, Castlegate Leisure opened Verve in 2006. Verve is also situated on Merrion Street, Leeds appealing to a slightly different age group with slightly different tastes (appendix 3, 4 and 5). Current hours Monday to Sunday 11:00 to 04:30. However, the theme is the same for both premises;

- Seating for over 60% of the patrons
- Provision of fine food/coffee offering during opening hours (appendix 6 and 7)
- Professional bar service with fully trained Cocktail Managers in both premises.

The Reform and Verve are bars but more than bars they are experiences where friends meet and can hear each other with the kind of music that doesn't deafen one in pleasant and almost palatial surroundings for an evening to be remembered in central Leeds.

Both premises currently feature in the "World's Best Bars". Reform being 23rd and Verve being 61st (appendix 8, 9 and 10).

CURRENT

"The Call Lane Application"

Conscious of the very real issues currently being experienced in the Call's district, in particular with the late night economy, Castlegate Leisure identified a premises at 38 Call Lane which would

ideally fit with their marketing strategy of raising the profile of the area and Leeds and offering a destination with a reputation for first class facilities for the night time economy.

Meetings were held with the Police Licensing Officer, WPC Cath Arkle and Chief Inspector Vernon Francis to explore the concept. Castlegate Leisure are aware that the Call Lane premises are in a Cumulative Impact Area and the onus is upon them as the operator to demonstrate that the offer of another licensed premises will not add to the impact already being experienced.

Objections to the application have been received by the Licensing Authority from several of the current operators of the Call Lane area.

Of relevance to the objections that are made by 3 of the objectors are the state of their operation currently. Leeds City Council promotes a scheme known as "Scores on the Doors". Whilst this refers to food hygiene, the fourth limb of the rating "confidence in management". Under this limb:

- Jakes Bar gain a rating of "some" (appendix 10)
- Oporto gain a rating of "some" (appendix 11)
- Norman Bar fares less well with Leeds City Council determining they had "little confidence" in the management of the premises and "awarded no stars".

Compare these scores with Castlegate Leisure facility Reform premises on Merrion Street (appendix 14) which was awarded high confidence in its management and a star rating of 5.

Working with the Police prior to the issue of the application identified several conditions which made both the Police Licensing Officer WPC Cath Arkle and Chief Inspector Francis comfortable with the proposition of Castlegate with respect to the facilities proposed for 38 Call Lane.

In addition to the conditions offered prior to discussions with the Police Licensing Officer and Chief Inspector, a further number of conditions were agreed:-

1. The suitable CCTV system will be maintained and be operational in the premises at all times when licensable activities are being carried out.
2. There should be a minimum of 55 seats maintained on the ground floor of the premises at all times when licensable activities are taking place.
3. There should be a minimum of 63 seats maintained on the first floor of the premises at all times when licensable activities are taking place.

Thus representing between 50% and 60% of capacity for each floor.

Additionally, discussions with the Environmental Health Pollution Control Team took place following the issue of the application (Leeds Environmental Health Pollution Team do not identify Officers to discuss conditions prior to the issue of an application).

The following conditions were agreed as being consistent with the operating schedule of the premises.

1. Licensable activities shall be conducted and the facilities for licensable activities shall be designed and operated so as to prevent the transmission of audible noise of perceptible vibration through the fabric of the building or structure to adjoining properties.
2. Noise from a licensable activity at the premise shall be inaudible at the nearest noise sensitive premises after 11pm and at all times if entertainment takes place on more than 30 occasions per year.
3. There shall be no external loud speakers.

4. Bottles will not be placed in any external receptacles after 11pm to minimise noise disturbance to neighbouring properties.
5. Noise from plant or machinery shall be inaudible at the nearest noise sensitive premises during the operation of the plant or machinery. Plant and machinery shall be regularly serviced and maintained to meet this level.
6. The Premises Licence Holder/DPS will ensure patrons use of beer gardens, external areas and play areas in a manner which does not cause disturbance to nearby residents and businesses in the vicinity. Patrons will not use such areas after 9pm.

(It has been confirmed by the Applicant that the rear area which fronts on to a residential area will not be used at all and is to be maintained as a fire escape).

7. The Premises Licence Holder/DPS will adopt a cooling down period where music volume is reduced towards the closing time of the premises.
8. The Premises Licence Holder/DPS shall ensure that litter arising from people using the premises is cleared away regularly and that promotional materials such as flyers do not create litter.
9. SIA registered door will be employed and used where queues are likely to form to manage the queues and ensure that queues are restricted to cordoned areas to prevent them obstructing footpaths and spilling out on to roads and to keep noise and obstructions away from the residential property.

Significant work has therefore been initiated prior to the issue of the application via a consultation with the Police and when appropriate, after the issue of the application during the consultation

period with the Environmental Health Officer, Noise Pollution Control Department at Leeds City Council. It is suggested to the Licensing Committee therefore that not only is there sufficient information attached to the operating schedule of the application both before and during the consultation period for this application but in satisfying the Responsible Authorities of the nature of this operation and their concerns with respect to paragraph 7.9 of the Statement of Licensing Policy have been satisfied and confirmation by the Responsible Authorities that they do not wish to object to this application confirms this view.

The Police Licensing Officer has also confirmed that she wishes the Committee to know that she fully supports this application and believes that the operator should have the opportunity, to change the demographics of the current visitors to Call Lane and reverse the trend of stagnation by the offer of a high class establishment not designed as a vertical drinking establishment.

Castlegate Leisure were one of the founding members of the Leeds City Centre operation Capital Two to provide street marshals from both of their current sites on Merrion Street for periods on both Friday and Saturday nights to support the work of the local Police Force and act as a deterrent to crime and disorder. Castlegate Leisure has also committed to the provision of a street marshal from 38 Call Lane should the Licensing Committee be minded to grant the Premises Licence for that facility.

The Police are satisfied that the operation of both the Verve and Reform facilities on Merrion Street is such that they have made no request with respect to polycarbonate or toughened glassware. The demographics of the current patrons of those premises are reflecting both the high and first class standards offered by them. It is proposed that 38 Call Lane not only meets those levels of service and ambiance but exceeds them in an effort to be identified as one of the top 10 cocktail facilities in the world and a destination premises for not only those visitors from London and the south but also further a field in Europe and beyond.

The current offering of both Reform and Verve will be reflected in the offering of the new facility in Call Lane. Patrons will wish to visit the premises to enjoy the ambiance and its cocktails and first class beers, wines and champagnes. The reputation of the other two premises is not based upon loud and intrusive music offerings which do not enable communication and conversation at normal speaking levels. It will also be apparent to the Committee that agreement with the Environmental Health Officer, Pollution Control Team reflects a continued determination not to be identified as a premises creating or tolerating noise nuisance.

Currently both Verve and Reform premises are involved in offering master classes in the preparation of cocktails both alcoholic and non alcoholic. Castlegate Leisure intend to extend these facilities to those NVQ students interested in following careers in the hospitality and bar facilities. Master classes for the under 18s will be tailored to their needs. However, agreement with WPC Arkle, Police Licensing Officer with respect the provision of these facilities has been agreed and does not in anyway compromise Castlegate Leisure with respect to the promotion of the licensing objective specifically with respect to the protection of children from harm.

Management of parties and events for 14 to 18 year olds will be approved with Police Licensing before they proceed.

The Committee may be aware that the premises at 38 Call Lane was until recently a shop selling guitars. Castlegate Leisure intend to completely refit the premises to reflect the layout and ambiance which is required for their marketing model. Whilst attention will be paid to the requirements of the Health & Safety Act and also the Fire Safety Order, it is also the intention of the operator to provide a self contained facility with no noise leakage. Currently the operation of the premises on Merrion Street, Reform and Verve meet these requirements. The two existing premises operate until 04:00 with a terminal hour of 04:30 (appendix 16 and17).

Planning Permission has been granted for the change of use.

Castlegate Leisure intend to use a dedicated taxi company with facilities within the premises directly linked to the taxi company. A dedicated pick up point around the corner from Call Lane will be identified so that residents and nearby neighbours are not disturbed by the slamming of doors or tooting of horns in the early morning. Of interest and considerable concern are the comments of some of the residents in the locality of Call Lane. The current operators are clearly responsible for a significant amount of noise emanating from their premises. The applicant is confident that he will not add to this in any way.

Castlegate Leisure believes that in bringing a facility which will be a reflection of the two other premises currently operated by them into Call Lane, it will change the demographics of the area and also improve the area as a whole as current operators will have to raise their game in order to compete with the first class offering at 38 Call Lane.

The Licensing Committee are therefore asked to consider the grant of the application for a new Premises Licence for 38 Call Lane, the effect that such a grant would have on the locality and the potential for attracting other responsible operators into the area. Adding high class facilities to the existing vertical drinking establishments improves the lives of residents in the locality but also improves the name of Leeds as a destination for upmarket first class night time economy activities.

Seriously easy going

We won't lie to you. There are a few things that Leeds lacks. Not many, granted, just one or two niggly things. A dedicated music venue for one, pot holes that don't swallow your car are another and, dare we say it, a decent football team? [we can already hear the sound of LUFC pens being put to paper].

However, one thing it certainly doesn't lack is diversity. From its people to its culture Leeds is as cosmopolitan as they come, and the same can be said for its bars.

Along with the usual chain store suspects, Leeds also has a plethora of vibrant, independent watering holes to cater for all palates and pockets. And should this later category be your terra firma, there's one end of town that most definitely should feature on your circuit.

Down The Headrow, towards Eastgate, lies what is now one of the city's most upcoming and fashionable spots for the seriously easy going. Here you'll find the likes of North Bar and Mojo – a regular with DJ Chris Moyles – all within stumbling distance of each other and having a passion for music like Augustus Gloop has for chocolate.

One of the latest jewels to arrive in this crown is Reform; a gem of a venue for those who put their Dylan before their dress code. It prides itself on its unpretentiousness, evidence of which is visible from even before you enter with some of the most courteous door staff you'll ever meet.

Move inside and the décor has echoes not too dissimilar to that of a gentleman's club – sumptuous leather arm chairs, dark flowery wall paper

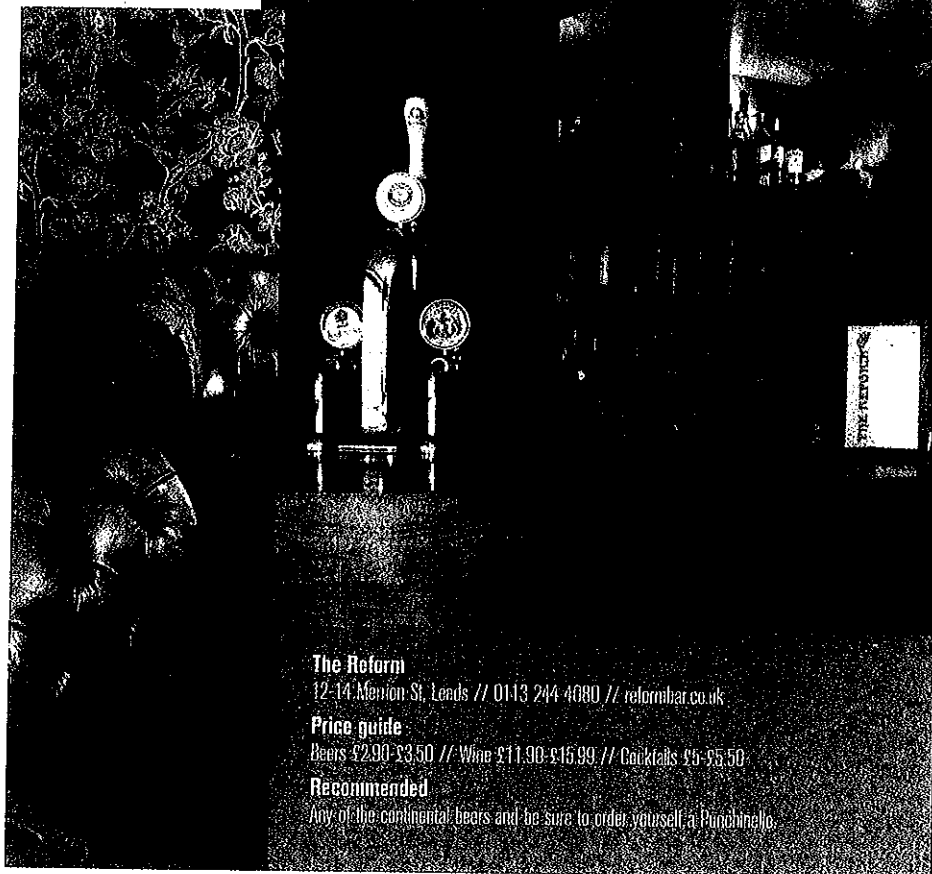
[overlapped with artwork from local artists] and candle lit tables all add to the venue's intimacy.

When it comes to drinks the offering is vast with an impressive selection of over thirty weird and wonderful continental beers – Chicago's Goose Island comes highly recommended. Add to this a host of elaborate cocktails, wines and champagnes and your evening should be warming up nicely.

Revellers don't come here purely for the comfy sofas and exotic beers, though, at Reform it's all about the music. Playing a non stop eclectic mix of funk, soul SKA and rock 'n' roll classics – from the Beastie Boys to Ben Folds Five – Reform's jukebox is so infectious that even iTunes itself is reportedly making a bid for it.

Local bands can even get in on the act too, as submitting demo CDs is openly encouraged, so much so that there's a bottle of Jägermeister waiting on ice for any group whose song appears in Reform's top 25 playlist.

Together with the likes of Mojo and North Bar, Reform has helped mould the northern edge of the city into hub for music and mojitos, where amps come before appetisers and easy going is definitely the order of the day.

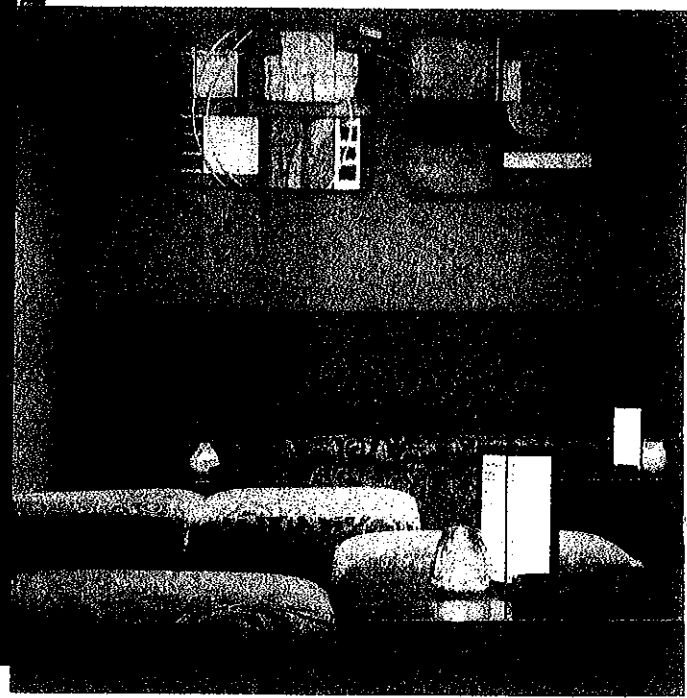
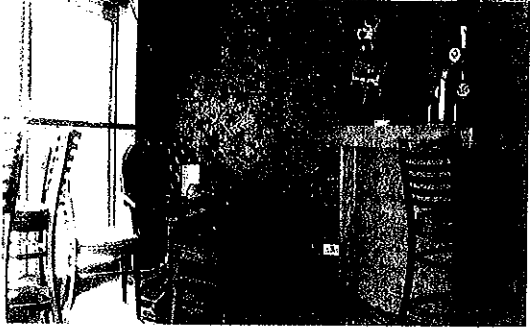
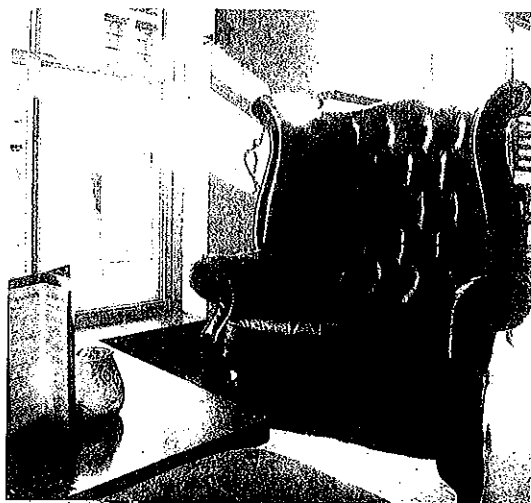

Revisited The Reform

Tom Goodhand rediscovers a bar where music and cocktails share top billing

What's in a name? Does it really matter what something's called, if it's still good? The Pigeon Detectives are doing perfectly well thank you, despite having one of the worst band names in history, while Sheffield's Smokers Die Younger, despite having a superb name, can wander the streets of their hometown hassle free.

So then, we have The Reform: a name suggesting improvement and learning from past mistakes. Whether there were actually past mistakes or not, we do not know, but it would be a misguided man who could pick out any real faults with the place now.

Arguably the highlight of The Reform lies not in the drinks (a very well chosen selection that we shall get onto later), nor the music (on the Friday night *Leeds Guide* went down it was something like an indie disco with notable offerings from Stone Roses, Happy Mondays and Editors, thanks to the bar's swanky iTunes set up in a corner of the bar) but in the décor. What man would not feel like a wonderful, upmarket dandy draped across The Reform's maroon leather sofa, martini glass in hand, sipping on a Manhattan? All we needed was a silk scarf and a gauloise in regular contact with the lips and we could have happily recited *The Importance of Being Earnest* verbatim — although it might not have gone down that well with a clientele gearing themselves up for a night out on the tiles.

Oh yes, and that Manhattan, the drinking man's cocktail, strong without being overbearing, and softly bitter. Truly a good drink. My partner opted for a Polish Martini: light, lemon-flavored and pretty much spot-on for a hot evening. With the

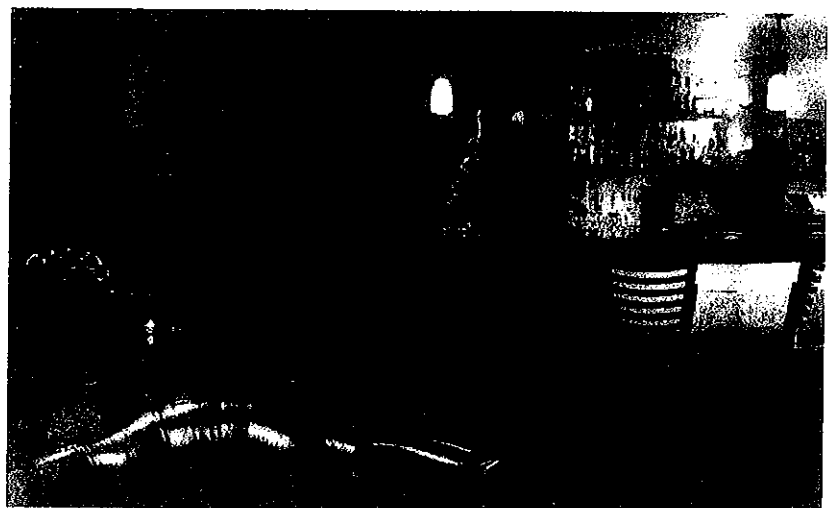
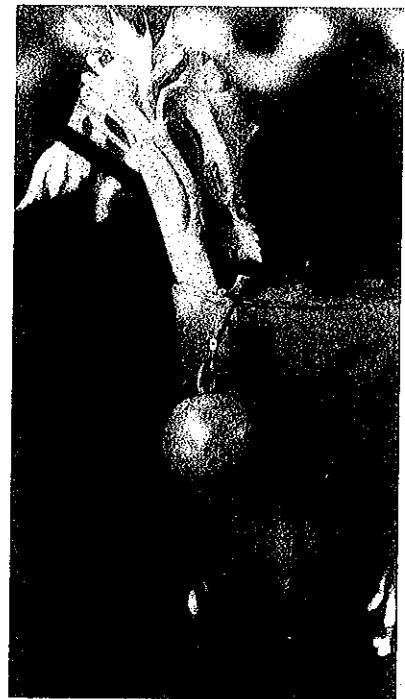
wide-ranging collection of cocktails never moving far over the five-pound mark — but retaining a high quality — they're perfect for a classy drink without busting the wallet.

Alongside the cocktails, there's an impressive range of spirits (obviously a must, if you're a bar offering cocktails), a well-stocked fridge of bottled beers, and the beers on tap are only from the higher end of the spectrum, with the wheat beer (Erdinger), the lager (Staropramen) and the flavored beers (Liefmans) all being represented.

Of course, living next door to Mojos and Verve, The Reform is in classy company, and so it bloody well should be.

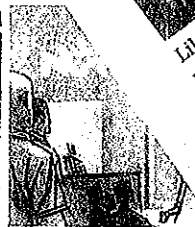

Like a younger, hipper version of its Merriam Street neighbour, Mojo, Verve is a credible attempt to combine good drinking and decent guitar music — something seemingly beyond most venues. Design-wise it's a bit nondescript, but at the bar they'll lovingly assemble an old-fashioned cocktail according to your specifications, or you can work your way through a refreshing range of lesser-spotted beers, such as Franziskaner, Gafel Kölsch, Tsingtao and Duvel Moortgat's Maredsous abbey beers. Musically, Verve charts a similarly discerning path, mixing acceptably obvious recent indie tracks or punk funk tunes that you'll struggle to name. Meanwhile, Roots, Verve's basement, ups the ante further, dobbing as a club venue, with monthly night Bad Behaviour bringing the noise. **TONY NAYLOR**

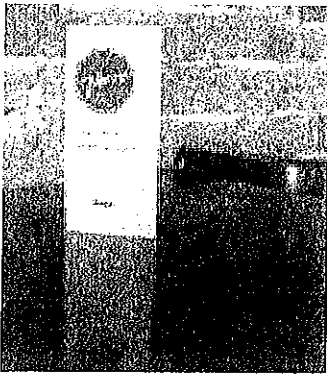

Verve and Style

Tom Goodhand enjoys stirrings at Northern Quarter bar Verve



“That’s just about the most work-intensive cocktail on our menu,” said Verve’s bartender, handing over a much-stirred Old Fashioned, “but it’s totally worth the effort. It’s also one of the best cocktails on our menu.”

When you can pop into a bar on a busy weekday night, order a cocktail that requires a good five to 10 minutes of stirring and preparation, and still be given a smile by a very friendly bartender, who keeps apologising for the time it takes to make the drink, you know you’re somewhere that really values customers.

Like its next door sister bar, The Reform, Verve really prides itself on four things: its beers, its cocktails, its music and its staff. The staff has good reason to be proud. *Leeds Guide* popped down to Verve twice in the course of a Tuesday evening — for a post-work pre-dinner beer and then later for a post-dinner cocktail to round off the night in style.

On our first visit, the lights were up, and there were people all around sampling the early bird two-for-one pizzas while sipping on a beer or two, enjoying the rock and indie music being piped throughout the bar. Being a sucker for Sierra Nevada pale ale, it was utterly irresistible, so the evening started off with a bottle of fine American ale, perched on bar stools overlooking Verve’s massive bay windows. My partner took advantage of the early bird cocktail offer to indulge in Vanilla Velvet — an oh-so sweet cocktail reminiscent of raspberry ripple ice-cream, and the pride of Verve’s head bartender Iain.

Having supped our first drinks, it was time to resist the temptation of sticking around for another and head off across Leeds for dinner. We promised to return later in the evening when

our appetites had been sated.

And return we did, to find the bar a somewhat different place. It was much more bustling, the lights were low and the music was turned up. It was definitely time for a cocktail, and I took on the aforementioned Old Fashioned. Superbly (and painstakingly) stirred and blended, the flavours were perfectly balanced, with the raw power of the bourbon perfectly tempered by the sugar and bitters.

My partner opted for a cosmopolitan to finish off her evening. When it

was (inevitably) ready much earlier than my Old Fashioned, our bartender was apologetic, explaining that he normally hates to serve orders separately, but the Old Fashioned really required his attention. I was, of course, completely happy with that. Quality takes time, and luckily, the bartenders at Verve are happy to put their time into making sure their customers leave not just satisfied, but impressed.
