#### 1 WELCOMES AND INTRODUCTIONS

Councillor Armitage welcomed all present and brief introductions were made

#### 2 BACKGROUND AND LEGISLATION UPDATE

The Licensing and Regulatory Panel on 22<sup>nd</sup> June 2010 resolved to create a small Working Group of Members to consider the development, content and implementation of a policy for the local authority to regulate Sexual Entertainment Venues in Leeds. The Policing and Crime Act 2009 had made powers available to local authorities to do so through an amendment to the Local Government Miscellaneous Provisions Act 1982 (Section 2 Schedule 3).

This introduced a new classification of Sex Establishment namely “Sexual Entertainment Venues” and a new licensing regime to Lap Dancing; Pole Dancing and “relevant entertainment” venues.

The documents before the SEV WG included:

- Letter from Mr A Campbell MP, Home Office
- Home Office Guidance on SEV's
- Copy of Schedule 3 of the Local Government Miscellaneous Provisions Act 1982
- First draft of an LCC Statement of Licensing Policy “Licensing of Sexual Establishments”

Members noted the legislation extended to shops and cinemas, but they stated their emphasis as being Lap Dancing clubs in the first instance as concern about the proliferation of such venues had been noted.

It was reported that 8 LD Clubs already existed in Leeds city centre. Members commented that historically these venues had not caused problems in terms of the Licensing Act 2003 objectives however comments had been made about some of the clubs with regards to possible links to criminality. The WG also noted factors which could be considered under the terms of the new schedule with regards to

- location (such as not near culturally sensitive areas);

- numbers (the possibility of choosing a stated number as being “appropriate for the city” within the policy); and
- conditions (such as advertising, window display).

The WG also discussed

- the role of stretch limousines as advertising vehicles in the city centre
- The approach adopted by other licensing authorities
- Relevant case law
- The benefits of undertaking an informal site visit in order to observe the business. It was suggested that an appropriate venue should be found – where the WG could observe without intrusion into the normal business of the club (such as CCTV room, or VIP area)

### 3 **EXPERT PANEL**

Members considered which of the suggested experts to liaise with from the list submitted. It was suggested that they would further consider the role of the Citizens Panel after a draft policy had been drawn up.

The WG were keen to meet with Professor Sanders who it was believed could provide an unbiased view of the entertainment and business as a whole, and guide members on which venue to visit. Comments would also be sought from WYP and HMCRS
