HMRC officers have made several seizures of illegal sales of illicit cigarettes and tobacco from Europa Stores, 344A, Dewsbury Road, Beeston, Leeds.

I have noted the dates and seizure amounts below for your information which I have taken from our Inland Detection Seizure file. These are not all seizures of goods I have been involved in personally:-

27/10/10 - 760 Cigarettes were seized.

31/10/10 - 400 Cigarettes and 1.35Kg of HRT (Hand Rolling Tobacco) were seized.

15/09/10 - 3560 Cigarettes and 0.15Kg of HRT.

16/09/10 - 4580 Cigarettes and 2.65kg of HRT.

19/09/10 - 5050 Cigarettes and2.35kg of HRT 22/09/10 - 700 Cigarettes and 2.45Kg of HRT were seized.

19/03/10 - 400 Cigarettes were seized.

20/02/10 - 580 Cigarettes were seized.

On the 19/03/10 - 16220 Cigarettes were seized directly from Mr Ali Joodaky. We witnessed Mr Joodaki delivering these cigarettes to Europa Stores from his vehicle - Reg No. KR05 KNX. The vehicle was also seized before being restored on payment of the duty to the amount of £2500. This amount was paid in cash.

In total 32250 cigarettes have been seized, which is approximately £6127.50 in evaded duty plus VAT at 17.5% at £1072.31 = £7199.81. The duty calculated at the current duty rate of equal to 24% of the retail price plus £114.31 per thousand cigarettes as per Budget day of 24 March 2010.

In total 10.1 Kilos of HRT has been seized. This comes to £1308.86 in evaded duty plus VAT at 17.5% at £229.05 = £1537.91. The duty is calculated at the current duty rate £129.59 per kilo of hand rolling tobacco as per budget day of 24 March 2010.
