The premises will be a food and drink outlet operating at Leeds Railway Station as per the attached plan (drawing number 2009/42/LP A).

The premises are situated on the concourse. The premises consist of a counter, seating area back of house and kitchen. The premises currently trade as Whistlestop Food and Wine covered by a premises licence (PREM/01244/V01) which will be surrendered on completion of the works.

The application is for Late Night Refreshment only between the hours of 23.00-02.00 daily.

KFC is a leading fast food brand operated under a franchise agreement by Select Service Partner Limited. The applicant runs in excess of 300 licensed outlets at railway stations nationwide. The premises are run in accordance with the company's own brand standards which deal with all aspects of the operation and also in accordance with the requirements placed upon them by Network Rail.

The premises are located at the railway station. The availability of licensable activities within the station is expected and required by the general travelling public and there is therefore a need for licensable activities.

Given the nature of the operation of the premises further measures to promote the protection of children from harm are not deemed necessary.


