# 1 Purpose of this report

1.1 Further the recommendations of the General Purposes Committee relating to the establishment of new arrangements for Plans Panels, this report seeks full Council's approval to the appointment of Members to those committees and to the appointment of Committee Chairs.

### 2 Background information

- 2.1 At the Annual Council meeting Member appointments were made to three plans panels covering the East, West and City Centre of Leeds.
- 2.2 General Purposes Committee has made recommendations to full Council to change those arrangements and, should those proposals be approved, it will be necessary to formally appointment Members to the new plans panels and also appoint Chairs to them.

#### 3 Main issues

- 3.1 Planning Committees are 'Ordinary Committees' and as such are subject to the provisions of the Local Government and Housing Act 1989 relating to proportionality. Additionally the Council's Constitution, at Article 8 contains provisions relating to the numbers of members that may be appointed to Plans Panel.
- 3.2 Given the important role of the Strategic Plans Panel, General Purposes Committee considered it appropriate for all political groups to have representation; to facilitate this, General Purposes Committee recommended to full Council that Article 8 be amended to dis-apply the membership restriction (set at between 7 and 11 members) to the Strategic Panel.
- 3.3 These recommendations were considered earlier on the Council agenda today and these proposals have been made on the assumption that Council has approved those changes.
- 3.4 At Appendix 1 to the report a schedule is presented outlining the apportionment of group appointments to each of the new Plans Panels and the names of the Members Council are asked to appoint.
- 3.5 At Appendix 2 to the report a schedule is presented detailing the Chairs of each of the Panel, again Council is asked to make those appointments.
