Summary of main issues

- 1. In a decision dated 20th June 2013, the Leader has made amendments to the executive arrangements. In accordance with the Executive and Decision Making Procedure Rules the Leader is required to present amendments to the Executive Arrangements to the next available meeting of Full Council.
- 2. This report details these amendments, including:-
 - Amendments to the Executive Members Portfolios;
 - Amendments to the Executive Members Overview of Roles and Responsibilities;
 - Amendments to Support to Executive Members; and
 - Amendments to the Officer Delegation Scheme (Executive Functions).
- 3. As a result of these amendments the Head of Governance Services has made additional changes to the Constitution for the purposes of clarification in accordance with his delegated authority.

1 Purpose of this report

1.1 To advise Council of amendments made by the Leader to the Executive Arrangements.

2 Background information

- 2.1 At the Annual Meeting on 20th May 2013, the Council received details of the Executive Arrangements put in place by the Leader.
- 2.2 By delegated decision dated 20th June 2013 the Leader has made amendments to the executive arrangements.

3 Main issues

3.1 The following amendments have been made to the Executive Arrangements for the reasons set out:-

Responsibility for Licensing

- 3.2 Responsibility for functions in relation to Licensing have been moved from the portfolio of the Deputy Leader and Executive member for Neighbourhoods, Planning and Support Services to the Leader of Council.
- 3.3 The amendment which is set out in detail in Section 3B(a) Executive Member Portfolios (Appendix A to this report), is further clarified in Section 3B(b) Executive Members Overview of Roles and Responsibilities (Appendix B to this report).

Support to Executive Members

3.4 Amendments have been made to Section 3B(c) Support to Executive Members, to specify the Executive member to whom support is to be given by each of the identified Deputy and Support Executive Members. The amendments are set out at Appendix C attached.

Officer Delegation Scheme

- 3.5 The title of the Assistant Chief Executive has been amended to Assistant Chief Executive (Citizens and Communities), and the Director of Environment and Neighbourhoods is now titled the Director of Environment and Housing. As a result the Officer Delegation Scheme (Executive Functions) has been amended in relation to the General Delegations (Appendix D attached), the Assistant Chief Executive (Appendix E attached) and the Director of Environment and Neighbourhoods (Appendix F attached.)
- 3.6 The Head of Governance Services has made a number of amendments to the constitution to ensure that these changes of title are reflected throughout.
